MARRY. PERIOD.

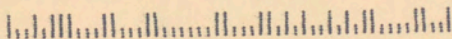

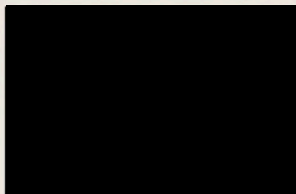
