STUDENTS' PERSPECTIVE ON ELECTION '92 LIVE ON C-SPAN
--On the Eve of Maryland Primary Students Discuss Candidates and Issues--

Washington, D.C., February 26, 1992 -- C-SPAN, the Cable Satellite Public Affairs Network, will air a **LIVE Election '92 High School Forum** from 4:00 to 5:00 pm (ET) on Monday, March 2, the eve of the Maryland primary.

The Maryland High School Forum is the second in C-SPAN's Primary season series designed to provide students around the country with an opportunity to discuss politics, the race for the presidency and issues important to young Americans, in a live television format.

The hour-long program will be telecast from the library at Richard Montgomery High School in Rockville, Maryland. Moderator Brian Lamb will be joined by guest Roger Simon, a columnist for the Baltimore Sun and author of Road Show, a book on the '88 presidential campaign trail, the electoral process and politics in America.

The forum is sponsored by "C-SPAN in the Classroom," the network's free membership service to educators, and by Cable TV Montgomery, a Hauser Communications cable system with a longstanding commitment to providing educational programming and equipment to local schools.
