<u>STUDENTS' PERSPECTIVE ON ELECTION '92 LIVE ON C-SPAN</u>
--On the Eve of Maryland Primary Students Discuss Candidates and Issues--

Washington, D.C., February 26, 1992 -- C-SPAN, the Cable Satellite Public Affairs Network, will air a LIVE Election '92 High School Forum from 4:00 to 5:00 pm (ET) on Monday, March 2, the eve of the Maryland primary.

The Maryland High School Forum is the second in C-SPAN's Primary season series designed to provide students around the country with an opportunity to discuss politics, the race for the presidency and issues important to young Americans, in a live television format.

The hour-long program will be telecast from the library at Richard Montgomery High School in Rockville, Maryland. 


