Dear Brian:

I have been an avid viewer of C-SPAN for over 6 years. I consider myself much more informed on national/political issues than the average citizen. My sources of information, prioritized by the amount of time I expend, are as follows:

- 1. C-SPAN
- 2. Talk Radio (Rush, Gordon Liddy, Alan Keyes, Mike Reagan)
- 3. The Wall Street Journal editorial page
- 4. The Washington Times Weekly Edition
- 5. The American Spectator, Reason
- 6. Books from the Conservative Book Club and my local public library

I have completely "tuned out" the mainstream media, which I identify as ABC, CBS, CNN, NBC, Washington Post, Los Angeles Times, Time, Newsweek, US News and World Report, etc. My reason for doing so is that I believe that these organizations are biased in favor of continuing liberal policies and that they have assisted in the creation of Bill Clinton's presidency and are working to assure his re-election. In my opinion, Bill Clinton and his wife are unindicted felons and an embarassment to this country.

I am self-employed as a courthouse researcher and consultant to attorneys, and am, at almost 59 years old, the undefeated race/endurance walking champion of Southwest Florida.
