Dear MAJORITY LEADER:

It is respectfully requested that a courageous open (C-SPAN televised) CONGRESSIONAL HEARING be initiated for the purpose of inquiring into the obvious U. S. Foreign Policy DISCRIMINATION in favor of "black" governments, and organizations, in sub-Sahara Africa. An objective rational investigation, with witnesses who do not fear biased racial intimidation.

The following reasonable questions should be boldly presented and rationally considered during the proceedings:

(1) Why has U. S. FOREIGN AID and assistance been continued, directly or indirectly, via various ways and means, to "black" governments with ABHORRENT records of oppression, disenfranchisement, terrorism, and the irrational killing of their citizens; and/or "black" governments, controlled by a black "tribe", which practices "tribal apartheid"?

(2) Why has there been NO SANCTIONS (economic, trade, etc.), and unrelenting criticism and harassment, against REPUGNANT "black" governments with ODIIOUS undemocratic oppressive records -- against "black" regimes that kill civilians by the hundreds and thousands?

(3) Why has the American people been deceived, primarily thru "omission" and disinformation, about the realities of traditional black "tribal apartheid" in sub-Sahara Africa? Why has the U. S. Government refrained from officially recognizing and acknowledging the unique white "Afrikaners" as a legitimate African tribe?

(4) Why has the "administration" and Congress, by word and deed, aided and abetted, for years, the violent revolutionary "black" African National Congress (ANC), whose devious "socialist" ideological goal is to gain supreme power over all the tribes (black & white) of South Africa, and "rule" the most advanced self-sufficient nation in sub-Sahara Africa? (ref: Failed Rhodesia experiment).

(5) Why has there been no unrelenting MORAL indignation and self-righteous OUTCRY, and no Congressional "Resolution", that officially CONDEMNS the ANC, and their associated United Democratic Front (UDF), South African Communist Party (SACP), and the ultramilitant "young lions" of the South African Youth Congress (SAYC)? (ref: ANC subversive destabilization of independent tribal homeland governments; programmed violent civil disobedience; "necklacing" and terrorism of opposition; association with socialist totalitarian governments and terrorist-expert Yasir Arafat; ANC active fighting alongside communist Angola-Cuban forces against USA-backed UNITA forces; AND the operation of "secret" slave labor camps where dissidents were tortured and killed (see enclosure).

(6) Why has the Afrikaner tribe, which controls the central government of South Africa, been defamed, degraded, sanctioned and unmercifully condemned, with unrelenting regularity, while "black" governments with FAR FAR MORE oppressive performance have been virtually ignored and/or REWARDED?

IN THE CONTEXT OF TRIBAL APARTHEID AFRICA, and in comparison to other tribes -- there is no doubt that the "Afrikaners" are one of the most civilized, humane and stable "tribes" in all of sub-Sahara Africa.

MAJORITY LEADER GEPHARDT, my principle interest in requesting a CONGRESSIONAL HEARING is to HONESTLY and FULLY inform the American people about the obvious double-standard black/white foreign policy.
