C-SPAN CALL-INS FOCUS ON SUPREME COURT CASES

On Monday, July 3, C-SPAN's live Viewer Call-in programs will focus on two cases pending before the U.S. Supreme Court. Both decisions are expected to be handed down that day.

At 6:30pm ET, the viewer call-in program will feature the two attorneys who argued the case of "Allegheny County v. the American Civil Liberties Union" before the U.S. Supreme Court, which addresses the issue of separation of church and state. Roslyn Litman, the attorney who represented the ACLU before the high court, and Peter Buscemi, who argued the case for Allegheny County, Pennsylvania, will discuss the case and answer viewer questions.

At 8pm ET, Sarah Weddington, the attorney who argued the 1973 case of Roe v. Wade before the U.S. Supreme Court, will comment on the abortion case, "Webster v. Reproductive Health Services."

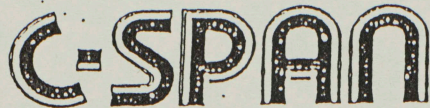

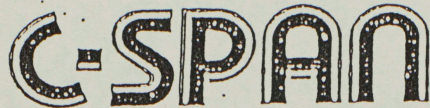
