Ex-wife of cop named in suit against Clinton is found dead

SHERWOOD, Ark. — The ex-wife of an Arkansas state trooper who is a co-defendant in a sexual harassment lawsuit against President Clinton died in an apparent suicide.

Kathy Ferguson, 37, was found dead of a gunshot wound to the right temple early Thursday at the home of her boyfriend, said Mark Malcolm, chief deputy coroner for Pulaski County. The boyfriend, Sherwood police officer Bill Shelton, called police.

Her death was being investigated as an apparent suicide, said Ray Snider, a police spokesman.

A note thought to be written by Kathy Ferguson was found near her body. It indicated problems in her relationship with Shelton, Malcolm said in a coroner's report. Another note found in a notebook apparently was from Shelton to Kathy Ferguson and questioned her relationship with another man, Malcolm said.

Ferguson had been staying at Shelton's home, but clothes on the couch and packed in a plastic bag suggested she was planning to leave, Malcolm said.

Ferguson's body was sent to the state Crime Lab for autopsy.

There was no known connection between her death and her ex-husband. Trooper Danny Ferguson said today the two had been divorced for about four years.

Danny Ferguson is named in a lawsuit filed last week by Paula Corbin Jones, a former state employee. She alleges Clinton made unwanted sexual advances to her in a hotel in 1991. Clinton was governor at the time. Her lawsuit said Ferguson invited her to the meeting with Clinton. She said she turned down Clinton's advances.

The White House said there was no sexual harassment.

Last year, Ferguson denied published reports that he and two other troopers were offered federal jobs by the Clinton administration to keep quiet about trying to arrange sexual liaisons for then-Gov. Clinton.

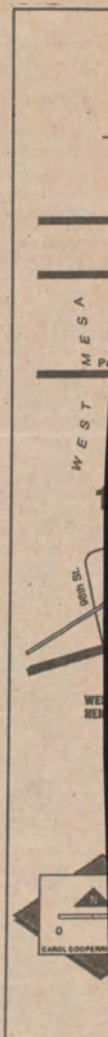

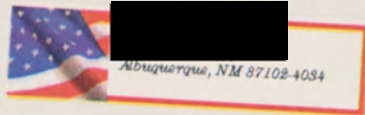
