## C-SPAN'S "ELECTION '90" EXAMINES TEXAS GOVERNOR'S RACE

Washington, D.C., June 26 -- The first installment of C-SPAN's new weekly series, "Election '90", will focus on the race for governor in Texas.

On Sunday, July 1, at 9:30 p.m. ET (8:30 p.m. CT), C-SPAN will air the acceptance speeches of Texas gubernatorial candidates, State Treasurer Ann Richards (D) and businessman Clayton Williams (R). C-SPAN will follow the speeches with a discussion featuring Carl Leubsdorf, Washington bureau chief, Dallas Morning News, and Tom Edsall, political reporter for the Washington Post. The guests will discuss the campaign issues and analyze advertisements used by the two candidates.

"Election '90" will continue through election day, airing Sundays at 9:30 p.m. ET. The 90-minute programs will highlight candidate speeches, debates, campaign spots, and interviews from Congressional, Senate, and gubernatorial campaigns across the nation.

C-SPAN is available in 50.3 million households through 3,835 cable system affiliates nationwide and around the world via satellite. The network is privately funded and is a public service of the cable television industry.
