✓ **First: Put the crooks in jail.** Those who betrayed the public trust should pay for their crimes—whether Congressman, banker, or President's son.

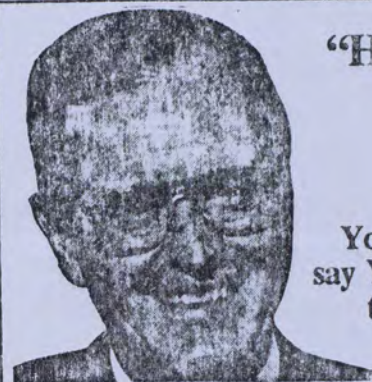
