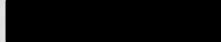

We Are Americans, Not Animals!

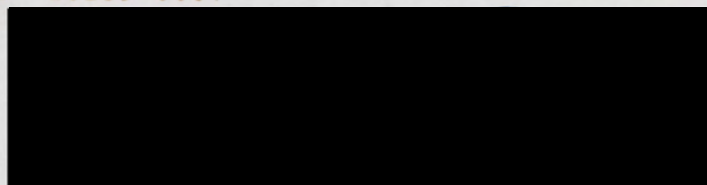

Therefore, it is requested that the people send letters to the United States Treasury c/o the Secretary of the Treasury, demanding a change be made to the Reduce the Public Debt Fund, Public Law 87-58. 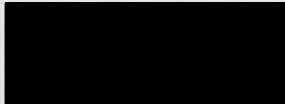

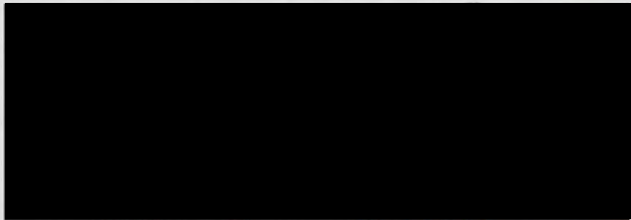

2. The U.S. Treasury is no longer recognized by the IRS. In 1961, the Public Debt Fund was put under the classification of charities and churches by Public Law 87-58. Some More

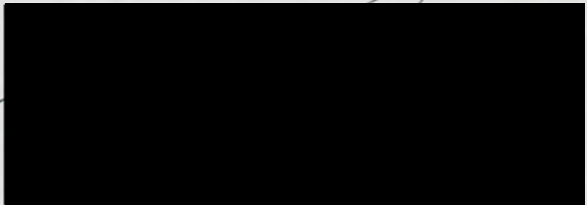
1. Let's Mandate: that Congress remove legislation it passed in 1912 called "The Federal Reserve Act." This act gave control of our (American people's) money to 12 Federal Reserve Banks and 300 stockholders that owned them.
2. Let's Mandate: that the United States Treasury be placed back in its proper place to control our money and congressional spending such that Congress cannot spend more than what is allocated by our treasury.
3. Let's Mandate: that the investigative arm of our Judiciary be removed from the "Freedom of Information Act," which has prevented our Judiciary from holding any congressman or senator responsible for their actions and corrupt legislation!
