Subject: Solution for immediate & long term recovery - no new taxes - spending cuts after recovery blooms - to absorb newly unemployed as occurring.

Sorry to learn you were smite by San Diego wobbles, then in Business Week 5-24 you were impregnated by Laura Tyson's theory, on save high wage jobs, which is sure death; inspires cite of empirical smarts, to avert your impending demise. After 25% are high pay - 50% are low pay - 25% are no pay -- who pays welfare! A scholar should see - Tyson's theory is an income leveler - after depression! High wage job *Inflation*, is #4 factor in USA's socioeconomic disaster, driving jobs over borders - Congress, Union Hierarchy, and FRBB are the 1-2-3 factors!

After our mindless Congress - operated on borrowed money - to near bankruptcy; to now, embark on same financial path as States, Counties, Cities, and Schools traveled for years, and are still strapped by *Inflation*, will get same result! The only thing your agenda does for USA's economic problems is - exacerbation!

You know!!! Cannon can't be beat into plowshares, without wedging established plowshare manufacturers, out of business...Especially with subsidized cannons! Lack of taxes or overspend didn't cause USA's problems, they're product of the problem, compound wage *Inflation* - which is the product of Congresses treason!

To address deficit before cause, is to bail sinking ship - before fixing leak! Your plan may reduce deficit today - but *Inflation* increases deficit tomorrow! If reducing deficit 500 billion in 5 years, as debt increases 1500 billion, is your best plan, after health care tax what's next, more taxes? Who's going to buy USA's junk bonds, unless interest rate is high and if so - more recession! There's no way debt-deficit can be paid, without first stopping wage *Inflation* [Argentina-Brazil], even then it's improbable without taxing economy to death!

You've proven self from same mold as Congressmen, long on personal gain, short on integrity and patriotism....You too, have chosen to circumvent addressing, USA's most threatening problem ever, compound wage *Inflation* - for reelection!

Japan-Germany didn't bankrupt USA by WWII or after, but Congress did by aiding Union Hierarchy, to loot USA and citizens via employers [*Inflation*] for votes! We're lucky: If Organized Crime was block vote, Congress would legalize crime! It's impossible to quantify depravation imposed on all citizens by Congress in pursuit of reelection; there's 6+ trillion borrowed and minimum of 2+ trillion wrested from employers, investors, suppliers, employees, by FRBB's recessions! While Russia was the victim of Communism --- USA is the victim of Congressism!

By collusion with Union Hierarchy and subsequent high wage *Inflation*, Congress has 199 committees to grapple issues it created, then points finger elsewhere! Congress-*Inflation* set stage: For healthcare mess - fingers Doctors-Hospitals: For TV violence and crime - fingers broadcasters: For latchkey kids & working moms - fingers moms: For unemployment-guns-crime - fingers criminals: For Los Angeles riots - fingers local conditions: For education degradation - fingers States: For high executive pay - fingers corporation: For Japan to win trade war - fingers Japan: For paving streets with high wage gold, luring immigrants - fingers Border Patrol: For USA's socioeconomic disaster - fingers fate: etc!

With Congress of 535 dropouts - USA's socioeconomic future, couldn't be worse!

Congress has personified the embezzler, who drove his employer [citizens] into bankruptcy, by selling assets [trust] for personal gain: reelection! [treason] What toppled Italy's government, is also toppling USA - corruption at the top! As accused, Congress won't declare insanity, doesn't fit - but stupidity does!

By complicity: You plan to sweep Congresses crimes under the rug, then resolve problems created, by new taxes and spend cuts - it won't fly, any way you try! You may delay parties demise, and retain campaign funds -- but, you will never ever turn, or save USA from ruin, until you address - compound wage Inflation!

The major reason for wage *Inflation*, that has created USA's debt, deficit, and crisis is Congress: By collusion with rewarding *Inflationary* interest, slanted *Inflationary* laws favor wage *Inflation*, colas, tax free *Inflationary* benefits! In 30s it was trade depression, now *Inflation* depression - thanks to Congress! *Inflation* did not arrive by itself - nor will it depart, without your efforts!

To get USA back on it's feet --- Consider Congresses crucifixion of employers! Now in straitjacket, next pillory, soon NAFTA with their feet set in concrete! Facing extinction, Congress continues to beat on employers for employee votes; Union Hierarchy beats on employer for employee dues; employers beaten to death cause employees to lose jobs; thanks to biased Congress, employers are scarce! Asphyxiated by Congresses *Inflationary* slanted mandates...Exterminated by Union Hierarchy *Inflationary* demands....Slaughtered by FRBB *Inflationary* recessions. Driven offshore, out of business by imports to control *Inflation*....Employers are endangered species, and must be saved from extinction, by warped Congress!

Congress tries to control *Inflation* it caused, by FRBB recessions and imports, causing innocent millions to lose businesses, jobs and homes; without remorse! You should know! that new tax and cut, won't alter Congresses habits and until it reforms, your plan, only robs Peter to pay Paul - hastening USA's collapse!

As we all need to know - 92 Congress ended in cow-lock, only because Congress, after years of irresponsible, self indulgence - without regard, and showing no remorse for damage done to, and no patriotism for USA - has shamefully painted itself, and USA economy with debt, deficit and ruin, into a corner; then cowed as only way out, is by new taxes or reform, and either, may cost - reelection! If Federal Reserve Bank Board, were worth their PhD's - they'd have known that business was operating on LBO high interest bonds, Banks and S&L's were paying high interest - had reams of high interest junk bonds - acres of high interest real estate loans, from Carter-Reagan-Volker 21% "imposed" recession, and knew of April 88, 3 trillion debt and 250+ deficit; to up discounts, to reduce 4.3% *Inflation* [now 3.3%], would push USA into another recession and never recover!

In Summary: A third world scenario you've read many times....History relates, USA was a major exporter and lender, until Congress divided prosperous economy into plots for it's partners to plunder - USA now a major importer and debtor! Congress - socioeconomically bankrupts USA - to reward self with - reelection!

Congress is culpable, but can exonerate self, with bipartisan "Solution" -- To compliment U.H. with mandate, U.H. won't oppose, that will Jump-Start and turn USA's economy 180 degrees - without political suicide, as U.H. remains intact!

Dramatically reduce EXPENDITURE and DEFENSE budgets, Promptly ELIMinate budget deficit, PAINlessly BALANCE the budget, drastically reduce NATIONAL & TREASURY debt and service cost, with combined Federal tax savings, of 7+ trillion first year, plus trillion and billion of 1993 value tax dollars annually thereafter, and removes all National debt, from our children's and grandchildren's legacy.

PLANacea eliminates: Trade and Budget deficits - Balances budget - Retires the National debt - With no new taxes or expenditure cuts - all at minuscule cost.
