DEAR CHAIRMAN BRIAN P LAMB,

IT IS WITH DEEP REGRET THAT I AM RECOMMENDING SENATE AND HOUSE HEARINGS CONCERNING VALUEPARTNERS I, SHREDDING OF DOCUMENTS, REMOVAL OF DOCUMENTS AFTER VINCE FOSTER'S DEATH, CATTLE FUTURES \$99,000 COMMODITY PROFIT (FROM A \$1,000 INVESTMENT?) AND THE ARKANSAS DEVELOPMENT FINANCE AUTHORITY (AFDA).

WHEN I VOTED AGAINST GEORGE BUSH AND THE REPUBLICANS IN THE LAST ELECTION, I VOTED FOR HONEST GOVERNMENT.

I BELIEVE THE PRESIDENT IS ABSOLUTELY CORRECT IN STANDING UP AGAINST THE HOUSE AND THEIR PORK. HE CUT PORK SO THAT WE WOULDN'T HAVE TO ENDURE A BTU TAX. ACCORDING TO THE "NEW YORK TIMES", SPECIAL COUNCIL ROBERT FISKE HAS MANY FRIENDS AND COLLEAGUES IN SENIOR POSITIONS IN THE PRESIDENT'S ADMINISTRATION. THEREFORE, THE HOUSE AND SENATE NEED TO HOLD HEARINGS NOW. I TRUST THAT YOU SHARE MY POSITION CONCERNING HONESTY IN GOVERNMENT. OTHERWISE, THESE SCANDALS ARE GOING TO SLOWLY UNRAVEL AND CRIPPLE CONFIDENCE IN OUR GOVERNMENT.
