AMBUSHED!

SOME OF THE MEDIA'S MORE SANCTIMONIOUS ADVOCATES FOR GUN-CONTROL ARE DISCOVERING THOSE WHO WOULD DISEMBOWEL THE U.S. CONSTITUTION BY REMOVING ARTICLE II, THE SECOND AMENDMENT IN THE NAME OF REDUCING VIOLENCE AND PROTECTING "OUR KIDS" ARE ALSO PREPARED TO DO THE SAME THING TO THE FIRST AMENDMENT, ALL IN THE PREMISE OF SAFETY.

ATTORNEY GENERAL JANET RENO TOLD A CONGRESSIONAL COMMITTEE THAT IF THE TELEVISION INDUSTRY DIDN'T CLEANUP ITS ACT WITH REGARD TO VIOLENT PROGRAMMING, THE CLINTON ADMINISTRATION WOULD DO IT FOR THEM. RENO TOLD THE SENATE COMMERCE COMMITTEE THAT THE TV INDUSTRY SHOULD BE GIVEN UNTIL 1 JANUARY 1994 TO CENSOR ITSELF INSOFAR AS VIOLENT PROGRAMMING IS CONCERNED, "BUT IF FURTHER SIGNIFICANT VOLUNTARY STEPS ARE NOT TAKEN SOON, I THINK GOVERNMENT ACTION WILL BE IMPERATIVE". AS WITH MANY OTHER STATEMENTS AND REMARKS BY JANET RENO, SHE HAS NO LEGAL RIGHT TO VOICE POLICY HOW AMERICANS SHOULD LIVE, WHEN THOSE REMARKS, THREATS AND PROPOSALS ARE IN DIRECT VIOLATION OF U.S. CONSTITUTIONAL LAW AND CODE OF JUSTICE.

THOSE REMARKS PROMPTED THE NEW YORK TIMES TO DENOUNCE RENO'S STATEMENTS AS A "DANGEROUS EMBRACE OF A VERY SEDUCTIVE FORM OF CENSORSHIP". THE TIMES IS CORRECT, BUT APPEARS TO HAVE MISSED THAT THE UNDERLYING JUSTIFICATION FOR RENO'S ATTACK ON THE FIRST AMENDMENT IS NO DIFFERENT THAN THE UNDERLYING JUSTIFICATION FOR HER PRIOR STATEMENTS, AND THE MEDIA'S ONGOING ASSAULT ON THE SECOND AMENDMENT: THAT VIOLENCE IN AMERICAN SOCIETY GENERALLY, AND THE DANGER THAT IT POSES TO CHILDREN IN PARTICULAR, JUSTIFIES THE ABRIDGEMENT OF FREEDOMS AND RIGHTS THAT HISTORICALLY HAVE BEEN DEEMED FUNDAMENTALLY INDIVIDUAL AND INALIENABLE DOCTRINE!

WHEN ANTI-GUN NEWSPAPER, BROADCAST AND TELECAST JOURNALISTS ARE PRESSED ON THIS POINT OF FACT, THEY USUALLY ARGUE THAT THERE IS A DISTINCT DIFFERENCE BETWEEN FREEDOM OF THE PRESS AND THE RIGHT TO KEEP AND BEAR ARMS - AND THAT DISTINCTION IS THAT NO ONE HAS EVER BEEN KILLED OR MAIMED BY WORDS, BUT THIS IS SELF-SERVING NONSENSE AND FALSE. WORDS, AND FOR THAT MATTER, PHOTOS, PICTURES, AND PICTORIAL GRAPHS, CAN AND DO CAUSE ACTIONS. THAT IS WHY THEY ARE SPOKEN, WRITTEN, BROADCAST AND TELEVISED IN THE FIRST PLACE. IF ANYONE DOUBTS THAT PRINTED AND BROADCAST MATERIAL CAUSE PEOPLE TO ACT IN CERTAIN WAYS, THEY NEED ONLY CONSIDER THE TENS OF BILLIONS OF DOLLARS SPENT EACH YEAR ON ADVERTISING.

EVEN THE LAW SYSTEM HAS LONG RECOGNIZED THAT WORDS CAN INJURE, KILL, OR LEAD TO CIVIL DISORDER. THAT IS WHY INCITING TO RIOT IS A CRIMINAL OFFENSE, AND WHY MOST STATES HAVE CRIMINAL LIBEL LAWS WHICH MAKE IT A CRIMINAL OFFENSE (AS OPPOSED TO A CIVIL ONE) TO SLANDER SOMEONE'S REPUTATION TO THE POINT WHERE HE OR SHE IS PHYSICALLY ATTACKED.

THE FACT THAT WORDS AND PICTURES INFLUENCE HUMAN BEHAVIOR IS PRECISELY THE REASON WHY IT WAS NECESSARY TO HAVE A FIRST AMENDMENT AT ALL. IF PRINTED AND BROADCAST MATERIAL WASN'T CAPABLE OF DOING THIS, NO ONE WOULD BOTHER WITH TRYING TO CENSOR IT!

LIKE FIREARMS, PRINTING PRESSES AND TELEVISION STATIONS ARE TOOLS THAT EMPOWER PEOPLE, AND LIKE FIREARMS, THEY CAN BE UTILIZED FOR GOOD OR EVIL. THE FRAMERS OF OUR CONSTITUTION WERE WELL AWARE OF THIS, HAVING SPENT MOST OF THEIR ADULT LIVES WAGING FIRST IDEOLOGICAL AND THEN ARMED REVOLUTION AGAINST WHAT THEY KNEW TO BE A TYRANNICAL GOVERNMENT.

THEIR WRITINGS AND DOCUMENTS LEAVE NOT THE SLIGHTEST DOUBT THAT THE FIRST AND SECOND AMENDMENTS WERE INCLUDED IN THE CONSTITUTION SO THAT GOVERNMENT WOULD NOT HAVE A MONOPOLY ON THE TOOLS OF COERCION.

THIS COUNTRY IS AT WAR! WE HAVE A GOVERNMENT OUT OF CONTROL WITH FEDERAL AGENCY ABUSE AND CRIMINAL MISCONDUCT. WE HAVE LIES, DECEIT, FRAUD, AND TREASON. WE HAVE A LACK OF LEADERSHIP QUALITIES AND INCOMPETENCE FROM AN ADMINISTRATION CAUSING UNNECESSARY DEATHS IN THE U.S. MILITARY. WE HAVE FURTHER POW-MIA DISCLOSURE BROKEN PROMISES, LIES, DECEIT AND COVER-UP. WE HAVE MALFEASANCE AND MISPLACED PRIORITIES WITHIN AN ERODED JUDICIAL SYSTEM OF LAW ENFORCEMENT EXCESSES BY UNFOUNDED "REASONABLE SUSPICION AND PROBABLE CAUSE" AND DOUBLESPEAK.

WE HAVE INEPT FUNCTION TO ADDRESS CRIMINAL OFFENSES IN FAILED GOVERNMENT POLICIES BY AN ADMINISTRATION THAT PROPOSES ILLEGAL PROVISIONS AND FLAGRANT VIOLATIONS OF SELF-DEFENSE CIVIL RIGHTS UPON LAW-ABIDING AMERICAN CITIZENS. WE HAVE HEINOUS CRIMINAL TERRORIST ATTACKS OF MURDER ACROSS THIS NATION WITH MISUSE OF FIREARMS, OBVIOUS TO FURTHER PUSH LEGISLATIVE ACTION TO BAN OWNERSHIP OF FIREARMS AND ULTIMATE CONFISCATION, WHICH HAS BEEN PROGRAMMED, ORCHESTRATED AND PREMEDITATED DELIBERATELY BY FACTIONS WITHIN OUR GOVERNMENT WHO ARE THE SOCIALIST-MARXIST "REVISIONARIES" WORKING TO USURP THE U.S. CONSTITUTION FOR TOTAL POWER AND CONTROL - SUBJUGATION.

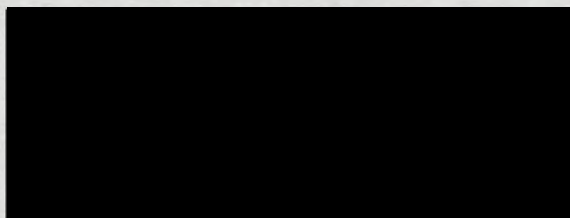
