1. No person under the age of 21 years shall:

- (a) Play, or be allowed to play, any licensed game or slot machine.
- (b) Loiter, or be permitted to loiter, in or about any room or premises wherein any licensed game is operated or conducted.

2. Any licensee, employee, dealer or other person who shall violate or permit the violation of any of the provisions of this section and any person, under 21 years of age, who shall violate any of the provisions of this section shall be guilty of a misdemeanor.

3. In any prosecution or other proceeding for the violation of any of the provisions of this section, it shall be no excuse for the licensee, employee, dealer other person to plead he believed the person to be 21 years old or over. *Ignorance no excuse.*

ELEMENTS

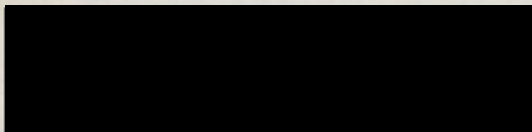
1. Establish age of suspect as being less than 21 years.

(name of parent or guardian helpfull)

2. (a) Act of playing or being allowed to play any licensed game or slot machine. (If minor is being allowed to play, show how person in control of premises acquiesced in said gaming activity).

3. (b) Loiter, or be permitted to loiter, in or about any room or premises wherein any licensed game is operated or conducted. (activity of loitering ie. having no lawful business of a particular nature in connection with the premises, must be shown along with the proximity of the minor in relation to the gaming activity or device).
