To Whom It MAY CONCERN:

I AM A postal WORKER AT the MAIN facility in Detroit AND I write you this letter with A story that REMAINS AS yet UNTOLD; NAME-ly, that my employer, the U.S. Postal Service, in collusion with the fed-ERAL office of WORKERS COMPENSATION (OWCP), HAS BEEN systematically defRAUDING employees, RETURNING to WORK FROM job-INJURIES, out of their federal health INSURANCE benefits (FEHB).

The mechanics of this FRAUD is somewhat dry AND CONVOLUTED, so I will only state that OWCP HAS BEEN ASSISTING the USPS in suppressing ANY official RECORD of ENROLLMENT in FEHB, thereby RENDERING the employee INELIGIBLE (UNABLE) to CARRY his health INSURANCE benefits into RETIRE-ment. By deCIETfully engineering A breech in the employee's FEHB en-Rollment the postal SERVICE CAN INVOKE the "5 year Rule" (that the em-ployee must show 5 years of UNinterrupted ENROLLMENT in FEHB IN ORDER to continue his benefits if he should go off the job, either thru RETIRE-ment OR disability). I caught the postal SERVICE in the ACT of trying to pull this stunt ON ME AND when I had questioned A COWORKER of mine who had likewise RETURNED to WORK AFTER A job-INJURY, I discovered that they had done the same to her. They hastily Reinstated her ENROLLMENT Retroactively to shut her up.

I brought this whole matter to the ATTENTION of A mid-level official in the "office of WORKERS COMPENSATION" (Dept. of LABOR) AND the INITIAL Response WAS dead silence AND then followed A horrendous campaign of Retaliatory HARASSMENT, both on the job AND AROUND my home.

Since the summer of 1994 I have been struggling to see justice served in this MATTER, trying to determine who polices the conduct of the postal SERVICE AND the Dept. of LABOR (OWCP). I am beginning to think that they ARE A law unto themselves AND ANSWER to NO ONE.

To put it crisply, I should state that upper officials in the USPS and Dept of Labor (OWCP) ARE ENGAGING IN CRIMINAL CONDUCT (FRAUD) AND NOBODY CARES. The official position of the Justice Dept. concerning these Allegations of WRONGDOING is that of indifference.

But then I thought of you, the NATIONAL PRESS, AND how NATIONAL publicity could force AN INVESTIGATION into this MATTER. One thing would happen for sure; if you MERELY stated my Allegations before A NATIONAL Audience, countless victims of this FRAUD would come FORWARD, which would VIRTUALLY substantiate my Allegations.

And so the PURPOSE of this letter is to Request that you bring these Allegations to the public's Attention, in the hope that this MATTER be investigated At last. I have Always Known the press to have A sense of civic duty; to bring to public Attention, WRONG-doing, wherever it OCCURS. I leave you my NAME, Address, AND phone NUMBER, in CASE you Need contact me, though I prefer that you CALL. (As part of the CAMPAIGN of HARASSMENT I AM being subjected to by the postal INSPECTORS, there has been considerable "interference" with my MAIL, both incoming AND outgoing. They CAN obstruct MAIL communications, but NOT phone calls

I CAN NOT let this last comment go by without some CLARIFICATION. The postal SERVICE has its own police force, known AS the "postal inspectors". Their MAIN job is to safeguard the MAIls, but ALL too often they serve AS management's "goon squad", ABUSING AND intimidating employees. My UNION CAN attest to their UNSAVORY Reputation. IN ANY event, it is the postal INSPECTORS who ARE CARRYING out, in LARGE part, the CAMPAIGN of HARASSMENT AGAINST ME.

But I digress; the HARASSMENT I have endured since my INITIAL FRAUD Allegations is too HORRIFIC to believe. You CAN NOT fathom how ABUSIVE the postal SERVICE CAN be to its' employees. The HARASSMENT they have subjected me to is every bit AS CRIMINAL AS the FRAUD they have committed. But that is ANOTHER chapter to this story that I will SHARE with you At A later date.

Postscript

I have intentionally chosen not to disclose the details of the campaign of harassment against me, at this time, for good reason. It appears that this campaign of harassment against me has had one persistent and abiding theme; i.e., that of portraying me as mentally unbalanced. Evidently the USPS-OWSP strategy has been to portray me as mentally ill in a bid to discredit me and, thereby, neutralize my initial fraud allegations.

My counter strategy is to push aside this campaign of harassment and hammer away at the fraud allegations until such time as the media publishes these allegations, which will bring forth other victims, and which will lead to a subsequent investigation. Only then, with some credibility under my belt, can I make a plausible harassment complaint. And what will follow will be a most extraordinary news story.

The USPS will, no doubt, claim that I am crazy when asked to comment on my fraud allegations. You are perfectly welcome to publish their allegations. I am not the least bit sensitive on this matter, because it is a big lie. But please do not allow the postal service to elude publicity on this matter by telling this lie. They say the proof is in the pudding, and in the end I am confident that I will be vindicated.
