JERRY J. JASNOWSKI (Indiana 1961) has been serving as president of the National Association of Manufacturers (NAM), the largest industry trade group in the country with 14,000 member companies, since 1990. Brother Jasnowski is considered one of the country's most respected authorities on political, economic and manufacturing trends. As such,


he has been a frequent guest on network and financial news programs. Jerry served on the economic transition team for President Carter and was appointed assistant secretary for policy at the U.S. Department of Commerce. In 1997, Jerry was awarded the Anti-Defamation League's Person of the Year.

OLIVER D. KINGSLEY (Auburn 1965), president and COO of Exelon Corporation and president and CEO of Exelon

Generation, was inducted into the State of Alabama Engineering Hall of Fame. Prior to his appointment as COO, Oliver oversaw the operation of Exelon Nuclear and Exelon Power. With more than 40,000 megawatts, Exelon Generation is among the largest power generators in the U.S. Kingsley had previously served as president and chief nuclear officer of Exelon Nuclear, overseeing the largest commercial nuclear fleet in the U.S. and the third largest in the world. Graduating from Auburn with honors, Kingsley began with the United States Navy Nuclear Submarine Force in 1966. He holds several industry leadership positions, and in June 2000 was recognized for his leadership in nuclear power when the American Nuclear Society awarded him the Walter Zinn Award.



→ **BRIAN P. LAMB (Purdue 1963)** received the Congressional Gold Medal on the 25th anniversary of creating C-SPAN, the



public service network which covers the proceedings of Congress. C-SPAN, which stands for Cable Satellite Public Affairs Network, began televising the U.S. House of Representatives in 1979. Since then, C-SPAN has grown to three 24-hour television networks: C-SPAN, reaching 86.2 million households; C-SPAN2, reaching 69.7 million; and C-SPAN3, which launched in 2001, reaching 6 million. Plus, there are C-SPAN Radio and nine websites. Brother Lamb also hosts the weekly three-hour morning show "Washington Journal."



CHARLES D. LEFFLER (Kentucky 1972), a 20-year veteran of facilities, finance and business at North Carolina State University, assumed the duties of vice chancellor for finance and business in August. He will oversee a budget of nearly \$1 billion and be responsible for all business and finance functions supporting NC State's teaching, research and extension programs. His responsibilities include all university

facilities and real property, which covers 113,000 acres statewide, with about 200 major buildings totalling 11.3 million square feet. Brother Leffler also oversees a current capital construction program of \$900 million and an operating budget of more than \$50 million, with development and management responsibility for almost 700 employees. Charlie has served on the BCA at the University of Cincinnati and as house corporation president and vice-president at North Carolina State.

KEVIN F. MITCHELSON (Kansas 1979) was recently re-elected by the members of the Kansas Highway Advisory Commission to a fourth consecutive one-year term as its

Chairman. An attorney in Pittsburg, Kansas, Brother Mitchelson was first appointed to the Kansas Highway Advisory Commission in 2000 by then Governor Bill Graves, and then re-appointed to a four-year term in 2002. The Commission advises the Kansas Secretary of Transportation on various issues, including recommendations for improving the entire highway system. Kevin also served on the Transportation 2000 Task Force. As an undergraduate, Brother Mitchelson served as Chapter President and Historian. He also received an Educational Foundation scholarship and is a member of Fiji Sires & Sons with his father, Fred Mitchelson (Kansas 1944). As a graduate, Kevin served as house corporation treasurer for Pi Deuteron from 1981-96.



JERE W. MOREHEAD (Georgia Faculty), an 18-year veteran instructor at the University of Georgia, has been appointed vice provost for academic affairs. Since 1986, Jere has

been a faculty member in the Terry College of Business legal studies. In 1998-99, he served as UGA's acting executive director of legal affairs, and he has led the Honors and Foundation Fellows programs since 1999.

Brother Morehead has received UGA's highest teaching honors and was twice chosen Outstanding Honors Professor and Business Teacher of the Year. He has authored

more than 30 books, book chapters and articles, as well as co-authoring a leading undergraduate legal textbook. Additionally, he has been editor-in-chief of the American Business Law Journal. As advisor to the moot court program in the School of Law for nine years, he helped student teams win five national championships. As the Purple Legionnaire at Kappa Deuteron, Jere has received the Durrance Award in 1995, 1996 and 2002. He has served on the BCA and has received a citation for Distinguished and Exceptional Service to the Fraternity.

STEPHEN D. OWEN (British Columbia 1970) is currently serving as Minister of Public Works and Government Services and Receiver General for Canada after his election to Parliament in 2000. Brother Owen previously served as Secretary of State, Parliamentary Secretary to the Minister of Justice, and as a member of the House of Commons Standing Committees on Justice and Human Rights, and Health. He was also appointed to the Prime Minister's Task Force on Urban Issues. At the University of Victoria, Stephen has served as director of the Institute for Dispute Resolution and professor of Law and Public Policy. He has also served as Commissioner and Vice President of the Law Commission of Canada and Deputy Attorney General of British Columbia.



STEVEN J. PAZOL (Michigan 1986), CEO of nPhase, a leading M2M technology company, was named one of the "Top 10 M2M Pioneers." M2M technology links machine to machine, machine to mobile and mobile to machine; in other words, enhancing business performance by connecting machines, people and information systems. In 1988, Steve began consulting independently after working for Burroughs Corporation and Unisys Corporation in the information technology field.




Additionally, he is the technical editor of the magazine *Unicenter Advisor* and has authored over 40 articles on a variety of topics for technology journals. His presentation at the 2004 National Manufacturing show drew nearly 800 attendees.

SCOTT D. PEARSON (Florida 1995) was named Branch Manager of the Year by STA Travel, the world's largest student travel agency with over 100 branches across the U.S. and Canada and over 400 branches world-wide. Scott's Knoxville branch grew 20% over the previous year and was one of the top seven most profitable in the North



American division for 2003. Part of his reward for achieving such results was an all-expense paid trip to the Fiji Islands, as well as a trip to London to the STA World Headquarters. Scott acquired a Fiji Republic flag, which he presented to the Florida Chapter at Pig Dinner.

JAMES P. PRENTICE (Alberta 1977) was elected as the Conservative Party's candidate for the new riding of Calgary North Centre with 54% of the vote. From 1991-95, Brother Prentice served as National Treasurer of the Party. Jim specializes in property rights litigation and served as Commissioner of the Indian Claims Commission of Canada for ten years; he is recognized as an expert in land claims negotiations. Before becoming involved in politics, Jim owned and operated weekly newspapers and is part-owner of several retail businesses. He previously served as Purple Legionnaire at Epsilon Alpha, on the BCA and as graduate chapter president and treasurer.



WILLIAM E. SCROGGS (Johns Hopkins 1969) was recently inducted into the Lacrosse Hall of Fame after 21 years of coaching. Now retired, he took the position of head lacrosse coach at the University of North Carolina in 1978 when UNC had known minimal lacrosse success. With three years of Willie's coaching, the Tar Heel team won the ACC title and the national championship. They had a repeat performance in 1982 and won four more conference crowns and another national championship in 1986. "I was inducted into the Hall of Fame not because I was a great player, but because I was able to get good people and point them in the right direction," Willie explains. In his address at the North Carolina Pig Dinner, Brother Scroggs stressed to the undergraduates the value of the support from many graduate brothers. He told them, "You will gain strength from [their support] if you appreciate it. Nobody ever pointed that out to me when I was your age."
