
## SUBJECT: C-SPAN: LACK OF COVERAGE BY PARAGON CABLE CO

IT WOULD APPEAR THAT YOU DO NOT CONSIDER C-SPAN PROGRAMMING IMPORTANT ENOUGH TO HAVE ITS OWN CHANNEL DURING THE DAYTIME HOURS.

IF THIS IS THE CASE, I WOULD LIKE TO HAVE YOUR RESPONSE TO THIS LETTER, AND FOR YOU TO EXPLAIN WHY, OUT OF SOME 40+ CHANNELS .... A MAJORITY OF WHICH CARRY MATERIAL WHICH CAN ONLY BE DESCRIBED AS OF MINIMAL SOCIAL VALUE .... YOU CANNOT ALLOCATE ONE OF THEM TO THE DAYTIME C-SPAN NETWORK.

FURTHER, I NOTE THAT YOU APPEAR TO HAVE NO PLANS TO INTRODUCE THE C-SPAN SOUND SERVICE. THIS IS, IN MY OPINION, UNACCEPTABLE FOR A GROWTH COMMUNITY SUCH AS EL PASO AND I WOULD THEREFORE BE GRATEFUL IF YOU WILL PLEASE EXPLAIN WHAT YOUR POLICY IS, IN REGARD TO C-SPAN, BOTH ON REGULAR TV AS WELL AS ON SOUND ONLY.

I AM A CONCERNED CITIZEN WHO BELIEVES THAT THE MATERIAL CARRIED BY C-SPAN IS NOT ONLY IMPORTANT, BUT ESSENTIAL TO OUR DEMOCRATIC WAY OF LIFE; A WAY OF LIFE WHICH IS IN DANGER OF BECOMING LESS AND LESS IMPORTANT TO OUR SOCIETY AS MORE AND MORE PEOPLE BECOME CYNICAL ABOUT WHAT OUR GOVERNMENT DOES AND DOES NOT DO. C-SPAN DOES MORE TO COUNTER THIS TREND THAN ANY OTHER MEDIUM AND I BELIEVE THEREFORE THAT YOUR COMPANY HAS A SOCIAL RESPONSIBILITY TO PROVIDE THESE SERVICES DURING DAYTIME HOURS.
