What is the Destiny of the Nation which turns its back on God's Law?

When the people of Israel came to Samuel demanding a leader to organize and protect their nation, Samuel delivered to them God's warning:

"This will be the constitution by which he will rule over you. He will take your sons for his chariots and horsemen, and to run before his carriage. He will appoint colonels of regiments for himself and captains of companies; also as mechanics in his workshops; as reapers of his harvests; and to make weapons for his soldiers, and appliances for his chariots. He will also take your daughters for confectioners and cooks and bakers, and he will take the best of your farms, and vineyards, and oliveyards, and give them to his ministers. And he will tithe your corn and wine, and give it to his officers and ministers. And your men servants and maids, and your best cattle, and asses, he will take and use them for his messengers. He will take your sheep, and make you his servants. And then you will shriek at the sight of your leader whom you have chosen for yourselves, but the Lord will not answer you at that day!" — 1 Samuel 8:11-18.

It has ever been thus for as long as the People have preferred worldly leaders to following God's Law.

It is so in America today! Consider the following points:

1. Our leaders have granted to themselves gratuities, immunities and privileges; they have accepted gifts in return for their favorable legislation and rulemaking; they have concealed the wrongdoing of themselves and their benefactors.
2. They have allowed the establishment of a privileged class with Titles of Nobility to have exclusive authority to operate before the Courts and to occupy the positions of Judges.
3. They have imposed a multitude of laws crafted to be beyond the understanding of the populace, requiring litigation by the privileged class for their interpretation.
4. They have changed the form of our government from a Republic to a Democracy by the creation of a corporate fiction "United States" and by deceptive contracts have imposed its corporate authority upon the inhabitants of the nation.
5. They have established vast bureaucratic agencies within their corporate "United States" with authority to promulgate regulations and impose penalties under color of law, using contracts to entrap and deceive the people.
6. They have assigned the control of the medium of exchange to a private monopoly of foreign agents who impose a usury money system upon the people and eat out their substance through interest and denied credit.
7. They have conscripted our sons and daughters into their armies to fight their senseless wars of protection of their privileged classes and the money lenders; and at their protracted conclusion, they have left behind those captured by the enemy and denied and concealed the evidence of their captivity.
8. They have placed the military powers of the nation under the authority of an international agency and foreign control.
9. They have destroyed the peoples' knowledge of their God by altering the writings of history, by denying prayer and reading of the Bible in the government's schools and in public places.
10. They have, through their "Supreme Court", made it "legal" for a mother to kill her unborn child.
11. They have altered our constitution by trickery, deception and fraud through the use of treaties, illegally adopted amendments and by denying recognition of amendments lawfully ratified.
12. They have driven the government into bankruptcy and delivered the wealth of the people to foreign agents while placing an unpayable debt upon the posterity of the people for generations to come.
13. They have built the Government to a magnitude of complexity and waste that is beyond repair by normal means.

We, therefore, find ourselves today in the same state as that of our ancestors, the Israelites at the time of Nehemiah, when he records that the people called out to God, recounting their own transgressions and disobedience and concluding:

"And our kings, our princes, our priests and our fathers have not practiced Your laws, and have not attended Your Commandments, and the instructions which You taught them. For they did not serve You in their reigns, and the plentiful prosperity You gave them, and in the rich and fertile country that You gave to their faces; nor did they turn from their wickedness. — Therefore we are slaves today, and the land that was given to our forefathers, that they might eat its fruits and its products, — we are slaves upon it! Yet it produced much for the kings You have set over us for our sins, and they control our bodies, and our cattle, at their pleasure, while we are in great distress. "Consequently on account of this, we have made a covenant . . .", and he here lists the signatories of the covenant. — Nehemiah 9:34 - 10:1.

By that covenant they swore to "walk in the Laws of God" which He had given them through Moses, and to observe His Ordinances, Statutes and Judgments.

We, likewise, are left with no choice except to renounce before God and Men this abomination, and to declare that we are a Free People whose only law is God's Law, His Ordinances, Statutes and Judgments; and our only King is Jesus Christ. And we covenant with God and each other that we will honor no other.

Notes and Documentation for the Foregoing Points:

1. The Congress gave itself a 35% pay raise at a time when many Americans were losing their jobs, American industry was being moved overseas and the national deficit and debt were, and still are, increasing beyond imaginable limits; they exempt themselves from most of the laws they pass; they solicit Political Action Committee (PAC) contributions and sponsor legislation for their favorite contributors. Refer to the S&L bailout, the "Keating Five", etc.

2. The American Bar Association was established under the auspices of the International Bar Association which is controlled from London. Members are entitled "Esquire" and operate under license as officers of the Courts, both State and Federal. They have exclusive access to the office of Judge at any level above County Judge. See also Luke 11:46, "And he (Jesus) said, Woe unto you also, ye lawyers! for ye have laden men with burdens grievous to be borne," and Luke 11:52, "Woe unto you, lawyers! for ye have taken away the key of knowledge."

3. Go to any law library, select any topic and ask to see all the laws, regulations and cases on that topic. Enough said.

4. State government's representation in the Congress was abolished by the seventeenth amendment. Article I, Section 8, Clause 17 and Article IV, Sec. 3, Clause 2, giving Congress exclusive authority over the District of Columbia and the federal territories, have been extended by contract and deception to include authority over the 50 states of the Union and the citizens thereof. See Title 26 U.S. Code Sec. 3121(e)(2) and compare to Sec. 4612(a)(4)(A), definitions of the United States as they apply to employment taxes and excise taxes, respectively. See also The Federal Zone by Mitch Modeleski in which the author describes the methods by which he claims the IRS extends its power of taxation far beyond the scope authorized by its own law. Any of the 50 United States is a foreign state to the United States (Corporate). Any corporation created by one of the States is a foreign corporation to the United States. See the Insular Cases, Downes v. Bidwell, 182 US 242 and DeLima v. Bidwell 182 US 1 (1901). Also see 26 USC Sec. 7701(a)(30) and 911(a)(1).

5. There are 279 agencies, administrations, departments and offices within the Executive Branch of the United States government with varying degrees of power and authority. Some act under the authority of Article II; others act under the authority granted to Congress by Article I, sec. 8; but most act by extension of the legislative authority of Congress over the federal territories and the extension of Amendment Article 14 to include the states of the Union and the citizens thereof. See The Federal Zone by Mitch Modeleski. Also see To Harass Our People by Congressman George Hansen.

6. Congress established the Federal Reserve System with the Federal Reserve Act of 1913 by which it allowed the majority of the class A stock to be owned by foreign investment bankers. It has assumed exclusive authority to issue currency against the credit of the United States and, with its member banks, to create money by action of extending credit through fractional reserve banking. This method of money creation makes it impossible for the people to repay the debt because the interest is never created. By regulation of the money supply and the banks' reserve requirement the Federal Reserve Board is able to, and does, control the level of economic activity in the United States. 12. The federal debt currently stands at something over 4 trillion dollars and is increasing at a rate of over one billion dollars per day. The interest on the debt which must be paid by the People is also over one billion dollars per day. Put into personal terms, the share for a family of four amounts to about \$6,000 per year for interest alone, and the family's share of the debt stands at \$64,000. The bulk of this debt is owed to foreign agents.

How Bad Must It Get?

The President of the United States demands that sodomites be allowed uninhibited practice of their perversion in the Military of the United States; churches professing to be followers of Jesus Christ are being attacked by armed raiders; the President demands that the federal government (the "taxpayers") pay for the killing of unborn babies unwanted by their mothers; the production jobs of United States workers are being moved to foreign countries in the name of "Free Trade"; the debt burden of the federal government is increasing exponentially with no restraint or correction in sight. It seems that this list could be extended indefinitely.

The Juggernaut* of Federal government has become so oppressive that the people are becoming desperate for relief. Yet, we refuse to accept the message of the ages, the tradition of our Fathers, the word of the Ever-living Creator. * [anything that exacts blind devotion or terrible sacrifice - Webster's - 1966 ed.]

Moses told the people of old, "thou shalt be only oppressed and spoiled evermore, and no man shall save thee." But we, in our folly, elect a President because he promises us "a change." And, so far, all the changes offered have been for the worse.

The evidence that our Constitutional Republic has been destroyed is now overwhelming. This article will review part of it and direct you to more. The chart on the reverse side shows merely a part of the penetration into all institutions by organizations whose interests are not the "life, liberty and pursuit of happiness" of the people of the United States of America. The choice we face today is the same choice that has confronted the people of God since the beginning. That choice was succinctly stated by Congressman Louis T. McFadden of Pennsylvania on the floor of the United States House of Representatives in 1933,

"Now, Mr. Chairman, we have come to the place where we must decide whether we shall serve God or Mammon. Shall we nullify the Constitution at the behest of the money-changers who have unlawfully taken all our gold and money into their own possession or shall we make a stand here in defense of the faith of our fathers?"

The answer was given to Solomon when he completed the house of the Lord,

"If my people, which are called by my name, shall humble themselves, and pray, and seek my face, and turn from their wicked ways, then will I hear from heaven, and will forgive their sin, and will heal their land." (11 Chron. 7:14)

But we deny our children prayer in their schools, bombard them with perversion under the guise of entertainment, send our children into "no-win wars," and allow atheists to determine how we should serve our God.

Where have we gone astray?

We can begin with the premise upon which the Public School education of our children is based. Twenty years ago, in 1973, Dr. Pierce of Harvard University addressed 2,000 teachers in Denver, Colorado saying, "Every child who enters school at the age of five is mentally ill, because he comes to school with allegiance toward our elected officials, toward our founding fathers, toward our institutions, toward the preservation of this form of government, patriotism, nationalism, sovereignty . . . All of that proves the children are sick, because the truly well individual is one who has rejected all of those things and is what I would call the true international child of the future."

In 1970, Dr. Paul Brandwein, a consultant for the Elementary and Secondary Education Act, Title III, wrote, "Any child who believes in God is mentally ill." Ten years later, John Dunphy wrote in the Humanist Magazine, "The classroom must and will become an arena of conflict between the old and the new - the rotting corpse of Christianity, together with all its adjacent evils and misery, and the new faith of Humanist."

The tenth plank of the Communist Manifesto states, "Free education for all children in public schools." The level of student proficiency has become one of the lowest in the world. Yet, those parents who have elected to "home school" their children are targeted for harassment by the government.

Is it any wonder, then, that prayer and the reading of the Bible are no longer permitted in the Public Schools? - that there is no understanding of the Constitution, or of how our economy and money system work?

What is more basic to our economic well being and prosperity than honest money?

How would the people react if the oil companies were authorized by Congress to change the quantity of gasoline in a gallon; or if farmers were authorized to change the quantity of wheat in a bushel; or if coal producers were authorized to reduce the weight of coal in a ton?

Would it be an overstatement to say there would be a revolution before dawn? And yet, this is exactly what has happened to our money system. Without complaint we allow the reduction in value of the "dollar" by the issuing banks through their participation in the Federal Reserve System.

The Dollar is defined in the U. S. Coinage Act of 1792 as 371.25 grains of fine silver. The word "Dollar" is a unit of weight just as a "gallon" is a unit of liquid measure and "bushel" is a unit of volume. To refer to a "Dollar" without saying of what is like saying "a gallon," or "a bushel," or "a ton" without specifying "of what." Congress, in fulfilling its authority under Article I, section 8, - "Congress shall have the power . . . to establish weights and measures," - established the weight of a "Dollar." That law has never been repealed nor amended.

We would recognize the fraud immediately if the size of a gallon, bushel or ton were reduced by the producer in order to get the same value for less product. Why does no one cry "foul" or "fraud" when the money issuer changes the weight of the money unit?

We have allowed the "money changers," the bankers, economists and educators to deceive us. They have convinced us that this reduction in value is a naturally occurring phenomenon called "inflation." Not only have they reduced the value of the Dollar to zero (now irredeemable in silver), but they charge interest for its issue. Then they compound the fraud by making it impossible to repay interest and principal because the interest is never created. All money is created through debt, but only the principal is created. If all debts, both public and private, were paid off, there would be no money in circulation since there is no money except that created by debt.

"The stranger that is within thee shall get up above thee very high; and thou shalt come down very low. He shall lend to thee, and thou shalt not lend to him: he shall be the head, and thou shalt be the tail." (Deut. 28: 43-44)

All the present argument in Congress about deficit reduction and paying off the Federal Debt only contributes to the confusion about the nature of money and conceals the

causes for the decline in economic activity, loss of jobs and export of industries. So, the economy of the United States is being gradually destroyed by the operation of its usury money system.

None of this should surprise us if we have read Proverbs 22:7,

"The rich rule over the poor, and the borrower is servant to the lender;" or Leviticus 19:35,

"You shall do no unrighteousness . . . in weight, or in measure;" or Proverbs 20:10,

"Divers (different) weights, and divers measures, both of them are alike abomination to the Lord."

The United States declared bankruptcy in 1933!

John B. Nelson, in his "Brandeis Brief" states that "the United States was 'Bankrupt' in 1933 and was declared so by President Roosevelt by Executive Orders 6073, 6102, 6111 and by Executive Order 6260 on March 9, 1933 as proclaimed under the 'Trading With The Enemy Act' (Sixty-fifth Congress, Oct. 6, 1917) and as codified at 12 U.S.C.A. 95a. Congress confirmed the Bankruptcy on June 5, 1933, and impaired the obligations and considerations of contracts through the 'Joint Resolution To Suspend The Gold Standard and Abrogate The Gold Clause, June 5, 1933', (HJR 192, 73rd Congress, 1st Session). The several States of the Union pledged the faith and credit thereof to the aid of the National Government, and formed numerous socialist committees, such as the 'Council of State Governments', 'Social Security Administration' . . . to purportedly deal with the economic 'Emergency.'

Secretary of the Treasury is a Foreign Agent!

Nelson continues by documenting the establishment of the "International Monetary Fund" (The Fund) and the "International Bank For Reconstruction and Development" (The Bank) as alien/foreign Financial Institutions (22 U.S.C.A. 286) naming the "Secretary of Treasury" as a Governor of The Fund and The Bank. Then in 1950, pursuant to Reorganization Plan No. 26, 5 U.S.C.A. 903, the Secretary of Treasury was appointed as the "Receiver" in Bankruptcy.

On August 15, 1971, President Richard Nixon reversed international monetary policy by officially declaring the non-convertibility of the U. S.

Dollar (Federal Reserve Note) into gold.

The Nelson brief proceeds to document evidence that the entire money system and most of the banks of the United States now operate under the control of the International Monetary Fund.

Source of Authority for Invasion at Ruby Creek, Mount Carmel, et al.

"In 1988 the Congress determined that the 'specific oath' required of Officers of the de jure United States of America was 'obsolete' and that INTERPOL Agents such as U.S. Marshals were no longer directed to service and labor to WE THE PEOPLE," but "are part of an 'International Force' under direction of the Secretary General of the United Nations. (See 'Oath of Office,' 28 United States Code, sec 563, in which there is no reference to the Constitution of the United States.)

"These expatriated aliens, under pretext and pretense of UNITED STATES (Marshal), were then given weapons/arms and ordered to take, seize, steal and trespass upon the property and rights to property of the Citizens of the several States, constituting an act of invasion, war, insurrection and rebellion by Foreign Powers and their Agents/Subjects."

Thus, Federal Agents could invade at will the property of Randy Weaver, Maynard Campbell and others, including the present so-called "stand-off" at the property of the Davidian sect at Mt. Carmel near Waco, Texas.

Why are the preachers silent?

At the time of our Declaration of Independence from England, the most prominent among those calling attention to the injustices and abuses of the "government" were the preachers of the day. What has happened to that tradition? Why are the preachers today not calling for an end to these "abominations?"

The answer is that they have agreed to remain silent!

Most churches are incorporated by state charter and are granted tax exempt status by the IRS under section 501(c)(3) of the Internal Revenue Code.

Section 501(c)(3) of the Internal Revenue Code (Subchapter F - Exempt Organizations) identifies those exempt under List of Exempt Organizations. (excerpts) "Corporations . . . organized and operated exclusively for religious, charitable . . . or educational purposes, . . . no substantial part of the activities of which is carrying on propaganda, or

otherwise attempting to influence legislation, . . . and which does not participate in, or intervene in (including the publishing or distributing of statements), any political campaign on behalf of any candidate for public office." (Emphasis added.)

In other words, those who contract to keep their mouth shut on Anti-Christian legislation before the Congress or Legislature and on the election of public officials are to be exempt from taxation.

Are these who Isaiah was talking about when he said, "His watchmen are blind: they are all ignorant, they are all dumb dogs, they cannot bark; sleeping, lying down, loving to slumber?"

"Yea, they are greedy dogs which can never have enough, and they are shepherds that cannot understand: they all look to their own way, every one for his gain, from his quarter." (Isaiah 56:10,11)

What people are responsible for keeping the commandments of God?

God said to Abraham,

"And I will make my covenant between me and thee, and I will multiply thee exceedingly." (Genesis 17: 1,2)

"And God said, Sarah thy wife shall bear thee a son indeed; and thou shalt call his name Isaac: and I will establish my covenant with him for an everlasting covenant, and with his seed after him." (Gen. 17:19)

Isaac's son Jacob, who was renamed Israel, (Gen. 32:28) (Is-r-ael, meaning "he will rule as God", see Strong's #3478) was the father of the Twelve Tribes of Israel who were referred to by the angel Gabriel when he announced the birth of Jesus to Mary, "And he shall reign over the house of Jacob for ever; and of his kingdom there shall be no end."

Howard B. Rand, LL.B. in *Digest of the Divine Law* provides a concise statement of the necessary corrective action:

"Evidence which cannot be lightly set aside definitely establishes the Anglo-Saxon-Celtic peoples as modern Israel today! This makes them responsible for restoring the Jehovah administration in obedience to their Divine Constitution. Only in so doing will justice be established upon earth and victory be assured over all their enemies. The time has come for His people to return, restore and again keep and administer all his commandments, statutes and judgements as the

law of their land. Isaiah prophesies of this time when he says, "There is no peace, saith my God, to the wicked." The sin of the House of Israel is her refusal to keep and administer His laws, and it is because of this refusal that peace has been taken from the earth and war, destitution, want and suffering afflict mankind. These afflictions will continue until the Anglo-Saxon-Celtic peoples awaken to their responsibility and make restitution of their Divine constitution. In fact, the pressure upon modern Israel will become increasingly disastrous until we fulfill our obligation and keep the oath our forefathers made at Mount Sinai when they said, "All that the Lord hath spoken we will do."

"Isaiah issues a challenge to modern Israel as he calls for those who know this message to 'Cry aloud, spare not, lift up thy voice like a trumpet, and shew my people their transgression, and the house of Jacob their sins.' (Isa. 58:1) Our national transgression is the refusal to administer His laws and this has become sin unto us. We will yet be compelled to keep all that law, for only in that way can we have God's blessing which will save our nation from destruction at the hand of the enemy who seeks our annihilation. Let us, therefore, study the laws of the Lord - which He required that we keep - in order that peace may come and happiness and contentment be assured to all!" (*Digest of the Divine Law* by Howard B. Rand, LL.B., Destiny Publishers, Merrimac, Mass., 1943, pp 35, 36) [* - Shouldn't Rand have included Scandinavian, Germanic and kindred peoples as well? - Ed.]

By what law are we to be governed?

"There is only one source and origin of all basic laws and this is true whether they govern the material universe, the physical creation; or the spiritual, moral and economic life of man. That source is God - the fountain-head of all law and order - Who has already revealed to men His Laws which govern an orderly creation. To know and to keep those laws is to live; while to belittle or disregard them brings destitution and want, until death terminates a life of sorrow and suffering, the direct result of failure to keep and observe the laws of God." (emphasis in original) - (ibid.)

Who is the "enemy who seeks our annihilation?"

The evidence is readily available. We need look no farther than the statements made by current and recent past government officials. For example,

George Bush, addressing the world leaders at the United Nations, said, "It is the sacred principles enshrined in the UN Charter to which we will henceforth pledge our allegiance." A pledge to the god of Mammon could not be more clear.

Other statements and programs by the members of the organizations represented on this chart and other kindred organizations identify those who seek our annihilation.

The choice is ours to make! Will it be God or Mammon?

We should take the words of Congressman McFadden, previously quoted, as our guide. He concluded his speech to Congress in this way,

"My mind is made up. I will stand by the Constitution. If I should fail to do so, I should expect to be met at the train when I go home by a delegation of honest Pennsylvania citizens with 50 to 100 feet of rope. I should expect to be escorted to the nearest tree to be taught what it means to vote for the nullification of the Constitution in the House of Representatives."

Sovereignty: The Time is NOW

F.R.E.E. supports the Sovereignty program which proposes that Congress create money (as the banks do now) and lend it, interest-free by a per capita formula, to tax supported entities to fund voter approved capital improvement projects and to convert existing debt from interest bearing to non-interest bearing. The underlying premise is that the people should not have to pay interest to money-lenders for the creation of money which the people have the power to create themselves through the powers granted to Congress. Since first proposed in January, 1989, this program has been endorsed by more than 1,730 cities, towns, counties and school boards. The U.S. Conference of Mayors endorsed the plan in Houston on June 24, 1992.

The money, created as loans, would be injected into the economies of the communities and, as repaid, would be extinguished from circulation.
