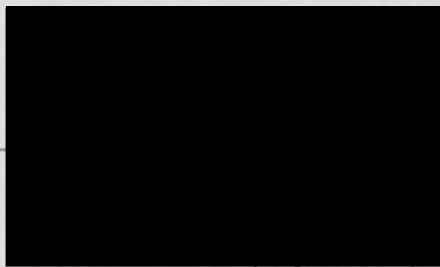

We are changing our party affiliation from Democrat to Republican. Because of the lies we have been expected to believe for so long.

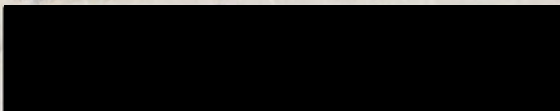
