is currently happening here in Seattle.

This bit of news covers - the executive Director  
of the Seattle Housing Authority, the District Attorney -  
a U.S. Senator.

So far there has been at least one verifiably  
attempt on my life - being fapped in the back - with  
one of those hand held - devices that put out I think  
about 500V. I'm not really sure what it was but  
it sure made me feel like I was having a heart-attack.

I've written the U.S. Senator & regarding this  
situation that is occurring at the SHH unit I live in.  
I've also written ~~the~~ president George Bush - sent the  
letter certified on the Jan 24<sup>th</sup> today I received the  
card back stating he received - at the white house  
stamp received the letter on the 28<sup>th</sup> of Jan.

I've also written the U.S. attorney Gen.  
just regular mail.

In another letter of inquiry - information  
I wrote to the U.S. Surgeon General - Washing D.C.  
certified mail and due to my mail being tampered  
with - packages being opened before I receive that  
package and receiving something different than  
what I've ordered. As well as several orders  
that I ordered in ~~the~~ OCT-NOV-DEC. of 1990 -  
I still have not received in fact one company  
keeps insisting that all items were shipped  
but I've not received them. Oh the mail problems  
what I've just mentioned has been reported to the  
U.S. Postmaster General by certified mail in D.C.



The Surgeon General & the Postmaster General letters were sent on Fri the 1<sup>st</sup> of 1991.

I don't watch C-Span very often but I do watch CNN quite often, as well as the movie channels - AMC & TNT as well as sports - ESPN especially since there's a lot of college basketball. Also that PSN does quite a bit of basketball as well as hockey. I guess that's about my main viewing interest and stations.

Oh, one other thing I've been attempting to establish a disability with Veterans administration as I was in the Service - Oct 56 - Sept 59 and again in Jan 62 to Dec 64. I was on that atomic testing (hi-altitude in the S. Pacific) in 62 - I was on [REDACTED] I was also in Thailand in 1963 - I think it was called [REDACTED]

Like the R.V.A. / Paralyzed Veterans group keep denying me - I think something is wrong because I'm on disability now - SSI.

So I'm a certified mail - to the V.A. in D.C. today - here as this letter to you.
