Attached is a copy of a letter I sent to you on 16 July 1996 (see area marked in yellow) -- I sent you another letter on 11 November hand written from home and therefore I do not have a copy of it. Both of these letters complain of a woman who is a regular caller to C-SPAN. On 11 November you also received an on-air telephone call complaining of her all too frequent telephone calls. Today she once again called within the 30-day window and you personally spoke to her.

She usually starts her calls with "I have to admit that I am a strong Clinton supporter" -but today she did not. She sometimes states she is calling from Connecticut and other times from
