C-SPAN AIRS LIVE VIEWER CALL-IN PROGRAM ON TERRORISM

Experts Discuss Domestic and International Terrorism

Washington, D.C., January 10, 1990 - C-SPAN will air a live viewer call-in program on terrorism on Friday, January 12, at 6:30pm ET. David Halevy, Jeff Kamen, and Geoffrey Levitt will discuss new forms of terrorism and efforts to combat it during the 90-minute program.

David Halevy is a journalist and consultant who has written for Time magazine for the past 19 years, specializing in military affairs and terrorism. He is a Lieutenant Colonel (Reserve) in the Israeli Defense Forces.

Jeff Kamen is a senior Washington correspondent and national security specialist for the Independent Network News, and the co-author of Final Warning: Averting Disaster in the New Age of Terrorism.

Geoffrey Levitt is a former counsel to the State Department's Office for Combatting Terrorism.
