Re: Homosexuals in the Military

I misplaced my notes (and the toll free number) on the above subject which aired on C-SPAN recently (Thursday or Friday) around 11 PM. I am interested in getting more information about the shocking revelations of child sexual abuse which were a part of this program.

Society is burdened with the tremendous cost of the social and criminal problems caused by the pain and suffering of millions victimized for life by child molesters. Too often the victims become perpetrators of the same abuse.

I would like to have a copy of the pamphlet by Congressman Dornan which lists health and other reasons for maintaining the ban on homosexuals in the military.

I did not see the entire program which featured a number of excellent and well informed speakers. I was particularly impressed by a very articulate lady - a Dr Reisman, I believe? - who castigated the authority of the world famous "Kinsey Report on Human Sexuality." All I know about that publication is that it combines Kinsey's two studies: "Sexual Behavior in the Human Female (1948) and Sexual Behavior in the Human Male (1953)." I am interested in having additional information from Dr. Reisman on the subject of sexual abuse of children.

Dr. Reisman, as I recall, posed this frightful question: "Who were those so-called "experts" who, during a 24 hour period, experimented on very young and helpless children and sexually stimulated them into having repeated orgasms? During that 24 hour period, those children had to be awakened from a sound sleep. Just what kind of people were on the Kinsey staff?"

I believe that Dr. Reisman said the children were as young as 3 and 4 years old and possibly younger; however, I want the facts verified. Only depraved minds could justify forcing innocent and helpless children to be the subjects of such unspeakable acts of degradation. One has to wonder what kind of parents would allow their children to be used so cruelly.

Pedophiles have sexually abused and traumatized children for centuries. Therefore, I was astounded that my 1975 edition of the New Webster's College Edition of the English Language omitted the word

"pedophile" describing their crimes against children. The 1990 edition of Webster's does, however, list it's damning definition: "one who sexually abuses children". Why the omission? Why were pedophiles protected from scrutiny by concealing the description of their aberrant sexual behavior? That information should have been readily available to students and the public. How can academia and Webster's board of editors justify listing the definition of the word "homosexual" and ommiting "pedophile?"

I am inclined to believe that the "sexual revolution" was fueled by the Kinsey Report on Human Sexuality. The sexual "experiments" on young children could only justify, expand and encourage the activities of pedophiles and child pornography.

As seen on world-wide television, homosexuals and lesbians recently put on an obscene and disgusting display in front of the White House. With an aggressive and defiant "IN YOUR FACE" attitude, many of them, outlandishly attired and virtually naked, flaunted themselves with repulsive and overt sexual gestures. Huge block lettered banners boldly proclaimed the name of the organization which promotes and advocates unrestricted sex with children. 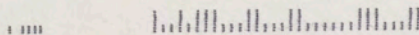
