OHIO GOVERNOR'S RACE FEATURED ON C-SPAN'S "ELECTION '90"

Interviews, Campaign Appearances by Candidates Featured

Washington, D.C., July 25 -- The Ohio governor's race between state Attorney General Anthony Celebrezze Jr. (D) and former Cleveland Mayor George Voinovich (R) will be the focus on "Election '90" this Sunday, July 29, at 12:30 PM, 9:30 PM, and 12:30 AM (ET).

The 90-minute program will feature a close-up look at the candidates and issues in the race, as well as "person-on-the-street" interviews with Ohio voters and a discussion of the campaign with Dayton Daily News political reporter Tim Miller.

Coverage includes a recent news conference on family and environmental issues held by Mr. Celebrezze in Lakewood, Ohio and a tour of Cleveland given by Mr. Voinovich. The program will also include back-to-back interviews with both candidates.

"Election '90," C-SPAN's weekly program focusing on the 1990 elections, provides viewers with comprehensive coverage of key House, Senate, and gubernatorial races.
