On Sunday, 8 December, you had as your guest Nancy Soderberg from the President's office. The host was Steve Scully.

A gentleman with a strong accent called C-Span expressing his concern with the newly named high-level cabinet appointees, and basically asked, (to paraphrase) "now that President Clinton has appointed primarily those of Jewish ethnicity into his highest cabinet level, what affect will this have in dealing with the Arab-Palestinian problem?" The caller was from Chevy Chase, Maryland.

It was obvious that this was an uncomfortable question from the expressions on Ms. Soderberg's face. And may we correctly assume that Ms. Soderberg is also of Jewish ethnicity? However, what is revealing was her answer to the caller's question:

"I object strongly to the tone of your conversation," and "you should 'think twice' before making comments like that."

Her own comments could also be taken as: "I don't like what you are saying, caller," and "you better not say it again if you know what's good for you." It was her undertone that implied one of threat to the caller, whose question was legitimate.

In a letter to you dated March 9, 1996 sent "anonymously" for obvious reasons, you asked to hear from your viewers because you had received several calls from people commenting that you appear to have a disproportionate number of people of "Jewish" ethnicity, or Jewish-sounding names or facial features as guests on C-Span and that you wanted to hear from us and our opinion on the subject. In my letter to you, which included documentation of my statistics and quotes, the majority originating from Jewish newspapers, I got the feedback that you considered letters such as mine as being mean-spirited. I guess the truth can be offensive.

I also presented statistics of Clinton's appointees as being over 56%, yet the percentage of Jews in the United States is somewhere around 2%. Does this mean we are still being paranoid even now because those statistics have gone up to around 90%, or is that, too, being mean-spirited.

One thing I can be grateful for is that Richard Holbrooke, (dare I say it, another appointee of Jewish ethnicity) did not receive the Nobel Peace Prize nor the job as Secretary of State, however much Madeleine Albright is offensive to many of us, which I will explain later.

During an interview with **Ted Koppel** (once again, dare I say it?) for The New Yorker, Richard Charles Albert Holbrooke revealed his racial hatred for the Serbian people when he called them "murderous assholes." His complete comment to Mr. Koppel was:

"The Vietcong were dedicated ideologues, committed to a long-term struggle. These guys (the Serbs) aren't ideologues; they're (The Serbs) just murderous assholes."
(Richard Holbrooke - The New Yorker, November 6, 1995.

I ask you, Mr. Lamb, is this a comment worthy of someone representing the United States? Someone who is supposed to be impartial? Mr. Holbrooke praises the communist Vietcong, who killed over 58,000 of our young troops and denegrates the brave Serbian people who fought, suffered and sacrificed as our allies during two world wars. His language is inexcusable and intolerable and full of hate, yet it went unchallenged by any member of the media, or any member of congress for his outrageous and blatant display of racism against the Serbian people.

Why? Because in his eyes and that of the American people due to the outstanding job of vilifying only one side in this civil war, the Serbs have no rights.

As for Ms. Albright, a very crucial letter, written by Lord Owen, was presented to the European Union which proved that Government Muslim forces had committed the breadline/markale massacre, (and subsequently, it was proven that all three breadline massacres were committed by Muslim forces), yet the American people were deluged with gruesome pictures of the mutilated bodies on CNN that blamed these atrocities on the Serbs. However, in the interest of US policy, and our vision as to who was the bad guy vs the good guy, Ms. Albright "spiked" this incriminating and damning letter from Lord Owen, thus preventing the American people from knowing the truth that the Serbs had not committed the breadline massacre. The fact that Bosnian forces had committed the breadline massacres were further proven when French journalist, Bernard Volker won his case in the Paris courts. In February of 1992, our Ambassador to Yugoslavia, Warren Zimmermann, (if you guessed his ethnicity as being Jewish, you guessed right), brokered the Lisbon Agreement that was agreed to by all three parties, Muslims, Croats and Serbs. After years of carnage, suffering and deaths, the Ambassador was heard to say, "in retrospect, the Lisbon Agreement wasn't so bad after all!"

I believe that what Ms. Albright did by deliberately withholding vital information from the American people that would have given the conflict a different perspective to be extremely dishonest, she will fit in well with that bunch of liars presently occupying The White House. She, along with Richard Holbrooke, were strong advocates of bombing the Serbs. Considering the praises Ms. Albright is receiving, even from Jesse Helms, bombing Serbian civilians, mostly women and children into oblivion, is now an attribute in the eyes of the American people. For what it is worth, the excuse we used for bombing the Serbs was based on the breadline massacre that was committed by the Bosnian government. How noble, we have become! To punish people for crimes they haven't committed. The Serbs could have stood on their heads this entire war, and they still would have been blamed for every nasty thing that has happened.

As Jacob Heilbrunn and Michael Lind of The New Republic editorial staff argue, **"That the American commitment to the Islamic connection is so strong that the US design is to make the Islamic world part of a new American empire and that American support of the Bosnian Muslims is part of the implementation of this plan."** (The Third American Empire, The New York Times, December 30, 1995). Simply put, Saudi Arabia wanted an Islamic nation in the belly of Europe whereby Muslims can flood from the Middle-East into Europe, and the United States wanted Saudi Arabian oil and money in exchange. Color me green!

We are the "Great Satan." We are the infidels. We are the enemy of Islam and must be destroyed, so don't kid yourself, my friend. After we have armed and trained these Muslim fanatics, and when the time is ripe, the day is not far off that we will pay for our folly and it is then that our kids will start coming back in body bags, that, and \$50 billion dollars later.

Our newspapers were filled with evidence of outright fraud during the Bosnian elections in September of 1996. Muslims were seen stuffing ballot boxes; there were 600,000 more votes than voters (The Washington Times, September 21, 1996, and The Guardian, 24 September 1996, by Julian Borger); yet, the United States, desirous of a corrupt Bosnian Muslim victory, declared the election to be "fair and honest." Once again, who was at the helm? Ms. Madeline Albright and Mr. Richard Holbrooke. And what do they all have in common? You guessed it. Yet it is quite revealing of the characteristic of those who have sided with the very people that tried to exterminate their people during World War II. Consider that during World War II, tens of thousands of Jews were saved by the Serbian people. Serbs took in Jewish children as part of their families protecting them from their persecutors and certain death. Those Serbs who were

caught hiding these Jewish children had their whole families executed. Over a million Serbs, Jews and gypsies were exterminated in the death camps run by Hitler's loyal allies, the Croats and Muslims. Over 500 American pilots were rescued by the Serbian National Forces of General Mihailovic while at the same time, Croat and Muslims were turning our airmen over to the Germans, yet, because of American aid and technology, we assisted Croats to slaughter 12,000 Krajina Serbs, ethnically cleanse over 200,000 from their ancestral lands, and watched Croatian jets bomb and strafe fleeing Serbian refugees without any condemnation from the "civilized" world. We (primarily the United States) have re-established an "ethnically pure Roman Catholic Fascist State of Croatia that Hitler only dreamed about yet the Jews of today have rewarded Serbian kindness and sacrifices with bombs, death and betrayal. As a result of the successful vilification of the Serbian people, today, in this country, Serbian churches are being desecrated, (spray painted with Nazi swastikas in Croatian, doors with evidence of urination, and four letter offensive words painted on the walls). Serbian children are being harassed by their teachers, and many Serbs have been fired from their jobs, even those close to retirement age. Americans of Serbian descent have received death threats, as well as have their priests. Serbs were blamed for bombing The New York World Trade Center (Paul Harvey) and by Congressman Bob Dornan, for murdering two French pilots (who were later released into Dutch custody in good health). They were accused of "torturing and mutilating, beyond recognition, five UN peace observers" These observers were also released several days after this news article appeared in The Washington Times. We saw video of peace observers being chained to poles by Serbs to be used as hostages, yet the only peacekeepers, *deliberately murdered* have been committed by Croats and Muslims.

In other words, it's all right for Muslims lie, cheat, and murder, but let the Serbs step out of line just once, it's **"Bomb Belgrade,"** or **"More Sanctions,"** as though we haven't punished the Serbian people enough by denying them food, warm clothing, medication, and even the chemicals to purify their water by US-led (Albright and Holbrooke) NATO sanction-approved genocide directed against only one side in this Bosnian civil war. We have reduced them to a monthly income of \$150 and their standard of living to that of a third world country. How proud Ms. Albright, Mr. Holbrooke and Ambassador Zimmermann must be.

I am enclosing a letter that was written by a Croatian politician to Archbishop Stepinac, who is being considered for canonization by the Vatican. It may help to explain why the Serbs are fighting fascism once again in this century and to prevent another 500 years under Islamic domination which we seemed determined to impose on the them. Just like the Jews, they are also saying, **"Never again."**

The letter was written by Croatian politician, Prvolsav Grizogono, on February 8, 1942 to Archbishop Dr. Alojzije Stepinac.

"I am writing to you as a man to a man, as a Christian to a Christian. I have been meaning to do this for months hoping that the dreadful news from Croatia would cease so that I could collect my thoughts and write to you in peace.

For the last ten months Serbs have been killed and destroyed in Croatia in the most ruthless manner and milliards of their property is being destroyed. The blushes of shame and anger cover the faces of every honest Croat.

The slaughter of Serbs began from the very first day of the establishment of the Independent State of Croatia (Gospic, Gudovac, Bosanska Krajina, etc) and has continued relentlessly to this very day.

The horror is not only in the killing. The killing includes everybody, old men, women, and children. With accompanying barbarian torture. These innocent Serbs have been impaled, fire has been lit on their bare chests, they have been roasted alive, burned in their homes and churches while still living, covered with boiling water and then their skin peeled off and salt poured into their wounds, their eyes have been pulled out, their ears, noses and tongues cut off, the priests have had their beards and moustaches raised together with their skulls, their sex organs severed and put into their mouth, they have been tied to trucks and then dragged along the ground, nails have been pressed into their heads, their heads nailed to the floor, they have been thrown alive into wells and abysses and bombs thrown to them, iron nails have broken their heads, children thrown into flames, into boiling water, into lime kilns, their legs torn from them, their heads smashed against walls, broken their backs against rocks and tree stumps and many other horrible torture was perpetrated, such as normal people can hardly imagine.

The rivers Sava, Drava, the Danube and their tributaries have carried thousands and thousands of their corpses. Dead bodies have been found with the inscription: 'direction Belgrade - travelling to king Peter'. In a boat which was found on the Sava river there was a heap of children's heads with the head of a woman (who could have been a head of one of the mothers of the children) with the inscription: 'Meat for the Jovanova Market in Belgrade'.

Horrifying is the case of Mileva Bozinic from Stabandza whose child was removed from her womb. There was also the case of the roasted heads in Bosnia, the vessels full of Serbian blood, the cases of Serbs being forced to drink the warm blood of their slaughter kin. Countless women, girls and children, mothers in front of their children and children in front of their mothers were raped or else sent off to Ustashi camps to serve the Ustashi, rapes even took place on the altars of Orthodox churches. In the Petrinja county a son was forced to rape his own mother.. The slaughter of the Serbs in the Glina Orthodox church and the murder of Serbs on the altar of the Kladusa church is without precedent in history. There are detailed and original accounts of all these horrors. Even the Germans and the Italians were astounded by these crimes. They photographed a huge number of cases of such slaughter. The Germans are saying that the Croatians did this also during the 30-years War and that is why there has been a saying in Germany since then: God save us from the plague, hunger and the Croats. The Srem Germans despise us because of this and behave in a more human fashion with the Serbs.

The Italians photographed a vessel with 3.5 kilograms of Serbian eyes as well as a Croat who wore a necklace strung with Serbian eyes and another one who came to Dubrovnik with a belt on which cut Serbian tongues were hanging."

There is more in the letter, but I have to stop typing now, I don't feel well after reading all this. When I regain courage to read the letter again, I'll continue.

PIUS XII: VATICAN AND USTASHE

"...The revival of a policy of forcible conversion assumes an even more portentous significance when one remembers that it occurred with the tacit approval of the Vatican. Had the Vatican disapproved not a single priest could have taken part in the massacres or forcible conversions of Orthodox Serbs. A village priest can act only with the approval of minor Hierarchs who themselves cannot move without the permission of their Bishop, while the Bishop, in his turn, must act according to the instructions of his Archbishop; the Archbishop only on those of the Primate; the Primate on the direct instructions of the Vatican. The Vatican is the personal dominion of the Pope. The Pope being the central pivot of the vast Hierarchical machinery, it follows that the ultimate responsibility for all members of the clergy-or, to be more precise, for the collective action of any given national Hierarchy - rests with him. This cannot be otherwise. For policies of great import must be submitted to him before their promotion by all Hierarchies the world over, the Pope being their sole authority. If the responsibility for the monstrous persecutions of Orthodox Serbs rests with the head of the National Hierarchy-i.e. Stepinac-it has automatically to rest also with the Head of the Universal Church, without whose consent the Catholic Hierarchy would not have dared to act--i.e. with Pius XII.

Pius XII could not plead ignorance of what was going on in Croatia by bringing forward the excuse of the obstacles of war. Communication between Rome and Croatia was as easy and as free in peace-time. From the very beginning of hostilities the Nazi Ambassador at the Vatican was treated as of far greater importance than all the Allied diplomats. In 1940 - 2 the Vatican was on the most cordial terms with Hitler. Political and religious Ustashi leaders came and went between Rome and Zagreb as freely as did the Germans and Italians, the Ustashi State then being a satellite of Nazi Germany, and hence a province of the Nazi Empire. Moreover, the Pope knew what was happening in Croatia, not only through the Hierarchical administrative machinery, which kept him up to date on all Croatian events, but also through other reliable sources. They were:

(a) The Papal Legate. Pius XII, it should never be forgotten, had a personal representative in Croatia, whose task was to implement Vatican policy and coordinate it with that of Pavelic, as well as reporting on religious and political matters to the Pope himself. The Papal Legate to Croatia was Mgr. Marcone, who openly blessed the Ustashi, publicly gave the Fascist salute, and encouraged Catholics (e.g. when he went to Mostar to be "faithful to the Holy See, which had helped that same people for centuries against Eastern barbarism"-that is say, against the Orthodox Church and the Serbs. Thus, the Pope's official representative openly instigated religious persecution, as well as praying for victory "under the leadership of the Head of the State Pavelic," against the Yugoslav National Liberation Army in 1944 - 5.

(b) Cardinal Tiseran, head of the Holy Congregation of Eastern Churches. This congregation's specific task was to deal with Eastern Churches. Cardinal Tiseran received detailed reports of every forcible conversion and massacre in Croatia. Between April and June, 1941 over 100,000 Orthodox Serbs were massacred; yet Cardinal Tiseran on July 17, 1941, had the audacity to declare that Archbishop Stepinac would now do a great work for the development of Catholicism in "the Independent State of Croatia...where there are such great hopes for the conversion of those who are not of the true faith."

(c) Ante Pavelic, who, by his representative to the Vatican, through whom Pius XII sent "special blessing to the Leader (Pavelic)," forwarded regular reports, at times straight from the Minister of Religions, about the "rapid" progress of the Catholicization of the New Croatia.

(d) Last but not least, Archbishop Stepinac himself, who in person visited Pius XII twice, and who supplied His Holiness with figures of the forcible conversions. In an official document, dated as late as May 8, 1944, His Eminence Archbishop Stepinac, head of the Catholic Hierarchy, in fact, informed the Holy Father that to date "244,000 Orthodox Serbs" had been "converted to the Church of God."

ПОКОЉ СРБА У ГЛИНСКОЈ ПРАВОСЛАВНОЈ ЦРКВИ

A special crescent-shaped knife, designed and produced in Solingen, Germany, was attached to the wrist to make the killing more efficient. Several Catholic Priests participated in a macabre contest to see how many Serbian throats they could slit within the shortest period of time by this method. The winner of this gruesome festival was Catholic cleric Petar Brzica, who won the contest held in Jasenovac, known as the Auschwitz of the Balkans, the third most productive death camp. In the course of the night of August 29, 1942, he cut the throats of 1,360 people with his own hands. This same method of execution was also used in a school by Francis Fria Filipovic. An unsuspecting teacher was asked to separate the Serbian children from the Roman Catholic children. Not knowing what horror was in store for the children, the teacher obliged the Catholic cleric from the Monastery of Siroki and separated them into two rows. The knife was then used to slit the throats of between 20 to 30 Serbian children sitting at their desks.
