C-SPAN ADDRESSES CURRENT ISSUES IN WORLD AFFAIRS

--Callers Question Key Players in East-West Relations--

Washington DC, March 11, 1992 -- Three upcoming Live Viewer Call-In programs provide C-SPAN's audience with an opportunity to speak directly with several key U.S. and Russian foreign policy leaders.

On Thursday, March 12 at 6:30 PM (ET), Henry Kissinger, Chairman of Kissinger Associates, Inc.; National Security Advisor from 1969 to 1975; Secretary of State from 1973 to 1977; and recipient of the 1973 Nobel Peace Prize, will discuss U.S. foreign policy and major issues affecting Russia, the Commonwealth of Independent States, Eastern Europe, and the Middle East.

On Friday, March 13 at 9:30-10:15 AM (ET), U.S. Ambassador to Russia Robert Strauss will answer viewer calls addressing U.S.-Russian relations. Then, at 6:30-7:15 PM (ET) Russian Ambassador to the U.S. Vladimir Lukin will discuss life in the former Soviet Union, U.S.-Russian relations, food shortages, and the upcoming Bush/Yeltsin summit.

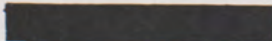

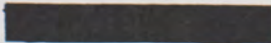
