TO WHOM IT MAY CONCERN:

Sir I am writing you because I have a problem with my Chain of Command. I took a TABE-A Test for ANCOC and I did not get a high enough score on it the first time. So around two or three weeks later I took the test again. I then receive the test score in my in box at the company. When I received the score I made a copy, I then gave the test to the First Sergeant for my packet around the 25th of March. Then on the 31st of March the Commander read me my rights. He said that he felt the score I received was not my mine he then said that he was charging me with Altering Public Record.

The Commander ask did I have anything to say at first, I did not know what he was talking about. Then he asked me about the TABE-A Test. I told him that it came to me in a Shot-gun folder addressed to me. Once I saw what it was I burned a copy of it off and turn a copy in.

The Commander told me to get with the Education Center and find out what's going on, so the next day that afternoon I went to the Education Center and asked for the Tester but I was told that he would be out for the rest of the week and the following week. So I returned to the Commander and told him that the tester would not be in for at least the next ten days, this was that Friday.

The following week I was told I had to go to Battalion to see the Sergeant Major. When I went to see the Sergeant Major he told me that I had a JAG appointment in the morning at 0845. He told me that after the appointment I should return to see him. I then said to myself that they are not even going to give me time to talk to the tester, so I went to JAG we talked and he had me fill out some paper work. Once I was finished he took my paper work in his office before he saw me. Then he came back out and said come in he then told me he wanted to check my handwriting out. He said it does not even match or come close to Alter this Public Record. He then said he had to go upstairs to talk with the prosecutor, he told her to get with my Commander to see if he wanted to drop the charges. So about a week later I heard that the Commander wanted to go forward and the reason why was my integrity is being question. He has never had any problem with me at all since I've been in this unit. So about four weeks went by and I did not hear anything. So I went over to the Battalion Command Sergeant Major office because I wanted to talk to him since no one in my NCO Chain of Command never

even til this date 15 May 93 asked me my side of the story. It seem they have made up their mine that I'm guilty so I question the Command Sergeant Major. I said to him every where I have been the First Sergeant and the Command Sergeant Major ask to here the other side of the story. Then he replied with he could not asked me nothing at all. I was really shocked, It's as if he did not care what I had to say.

On the 21st April 93 I received a Nigger Application for employment I was shocked I knew we had some Racial Problem in this Battalion but this is crazy. The Commander also told me that the tester don't have me log in as taking the test. I told him that he never required me to or told me to sign anything. So my Lieutenant asked me to retake the test again. I did better then the last two times on the third test. The tester did not tell me to sign in again, this time I had a witness because this other soldier went to take the test

and the tester did not tell him to sign in either. The tester gave us the answer sheet and then the booklet. He then told us we had so many minutes to complete the first portion of the test, then he left the room at that time I told the soldier to stop and go and sign in, Name, Rank, Unit etc., the tester came back about 10 minutes later after the clock went off. He told us to do the second part, then once you are finished place the answer sheet in the booklet put it on his desk and leave. I was the first one finished so I waited for the other soldier to come out the test room and I took him to see my lawyer. He wrote a sworn statement saying that the tester does not informed you to sign in nor does he check the roster to see who is there. I told the tester I wanted my result back the same day he told me to come back at 1300. I returned at 1315 he was not in the room the test paper and booklet was still there where we left them after we took the test. The tester was no where around at that time I started to take the booklet with the test to the Military Police Station but they would say I stole the booklet. So I went and found the tester down the hall talking to some guy I told him I come for my test result. He then went back to his office where he graded my test while I stood there and gave me the same type of paper I received in my in box. He said he would input the score before the end of the week and this was Monday, so every week for six weeks after I went to the Education Center to see if the score was put in and there was no new input in my records. Every time I went and got a copy of the print out no new score yet.

On the 10th May 93 I was read a Summary Field Grade, I'm not going to accept this either, I requested to see the Brigade Command Sergeant Major so I can see the Division Sergeant Major because he is the only one I trust. This is the fourth week and the Battalion Command Sergeant Major want to make me an appointment I have been using my Chain of Command. I want

to prove I did not alter any paper work. The Battalion Command Sergeant Major was question by another First Sergeant why he has not let me seen the Brigade Command Sergeant Major. He got upset that some one was concern, so this First Sergeant said he will be more than happy to speak on my behalf because he know what's going on.

Sir I'm the type of NCO who don't and won't bite my tongue. I'm for the soldiers because one day these young soldiers will replace me. Also I just found out I made the Sergeant First Class (E-7) list, everyone who made the list from the Battalion had to go to the Battalion. We were told then, the Battalion Command Sergeant Major shook the NCO hand he act as if he did not want to shake my hand. So I walked up to him and shook his hand to show him I'm an NCO and a man. If you don't like me it does not matter because God knows whats right and wrong. If they would let me prove to them that I did not do it but the Chain of Command don't want to here me they want me to prove it in court when by all right it can be proven now. The only reason I think they are pushing because I am supposed to go to ANCCO on the 27th June 93. If I can get to resolve this by the 5th June 93 I can still make my class date. Please can you react on this matter as soon as possible. My Commander has a integrity problem and I can prove that also, he does not care about his soldier health or welfare. I am a Platoon Sergeant, I have forty-five (45) soldiers who worked for me most of them are good soldiers maybe about five (5) are slower than the others they don't feel as though the Commander support them after talking to them. We have a First Sergeant who don't want the job so the soldiers are lost in a way. There have been time when First Sergeant has not showed up for formation me as an Staff Sergeant (E-6) have to take the Company Formation and there Sergeant First Class (E-7) standing in formation he won't take charge. I get paid to take care of soldiers. On the 14 May 93, I was given a job at Battalion Maintenance until this is over with. I would like to talk to the Division Command Sergeant Major Jackson maybe you can make and appointment for me since my Chain of Command is keeping me from seeing him.

He is a professional NCO to his heart. There is a Racial Problem here you would not believe there need to be a big investigation here. If you speak out they try to get rid of you no matter what it takes. Slavery days are supposed to be over with. In this Battalion the Command Sergeant Major Wyatt think if you are black you are stupid. There are things happening like two (2) white and one (1) Spanish Sergeant (E-5) these NCO jumped on a lower ranking soldier beat him down while they hold him nothing happened to the soldiers who did the beating they still remain NCOs. There are a lot of situations that I could go into if I wrote them all down. Now they would try to cover there tracks, I need some one to investigate here first. He has done so much wrong that its about to hit him straight in the face. He is

turning in his retirement paper work now, so he can hurry up and get out of here. Please have something done to stop it until some one can check out the problems he has cause.

If you are white you get taking care of, that's a statement he was supposed to had made and that he was tried of seeing all of these blacks in charge and slowly he is replacing us by lying on us to Higher Headquarters. He will make a comment like who do you think they will believe you are me because he is a Senior NCO. He has everything but a white sheet over his head.

I have Sergeant First Class (E-7) and above who are willing to talk as you read this letter also lower enlisted soldiers too. Please come to me and the other soldiers aid. If you notify them that you are coming they will try and hide or send certain soldiers on detail so you wont talk to them thats why I would like for some one to come and see me first or as soon as possible.

Thank you for your co-operation in this matter.

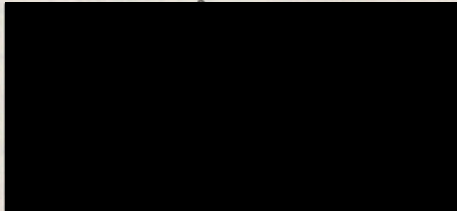
