Washington D.C., April 3, 1992 -- On Saturday, April 4 at 7:00 PM (ET), C-SPAN's weekly program on the American judicial system examines the issues behind Jane L. v. Bangerter, which will be argued on Monday, April 6th.

The case challenges Utah's abortion law, which passed a year ago. The guests on the program will be the two attorneys who will argue the case in Utah District Court--Mary Anne Wood for the State of Utah and Janet Benshoof for the American Civil Liberties Union.
