A federal budget deficit nearing two hundred billion dollars! Questions and answers before Congressional Committees and debate on the floor of the U.S. House of Representatives, as shown over C-SPAN, enable me to stay in the conversation about such a heavy subject. Crisis in Social Security and Medicare, entitlement programs, overruns and renegotiation of defense contracts, International Monetary Fund, Super Fund for environmental clean-up and political charges surrounding it, Tax Reform Act of 1981 and tax shelters such as sell-lease back and corporate tax credit leasing, bankruptcy of air lines and undertone of union busting, oil company mergers, enforcement and/or deregulation of consumer protection laws, civil rights enforcement, El Salvador, Lebanon, line item veto, and constitutional ammendments on right to life, equal rights, prayer in school and a balanced budgetare my reasons for watching C-SPAN.
