

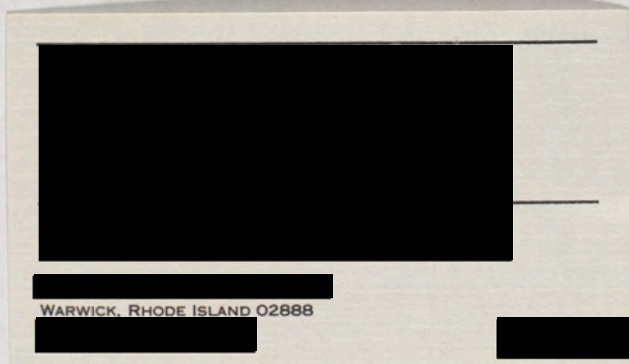
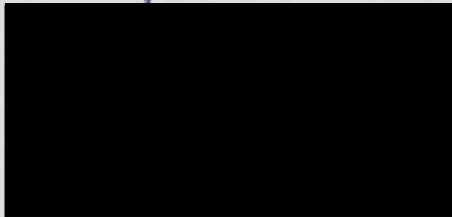


Thank you for your interest in S. 784, the Dietary Supplement Health and Education Act of 1993. Your support and encouragement for this bill are very much appreciated.
