DEAR MR. BRIAN LAMB:

IT'S TOO BAD YOU NEVER READ YOUR LETTERS BECAUSE
IF YOU READ THIS ONE, YOU MIGHT INVITE SOMEONE
FROM SOCIAL SECURITY TO EXPLAIN TO SOMEONE
FROM AN ORGANIZATION, A NON-PROFIT ONE,
WHICH IS TRYING TO PRESERVE SOCIAL SECURITY.

I SAY THIS NOW BECAUSE OF ALL THE
NOISE YOU ET AL ARE MAKING OF THE 50TH
ANNIVERSARY OF THE INVASION OF 1944, NOW,
YOU SHOULD KNOW THAT THE PRINCIPLE VICTIMS
OF THE SOCIAL SECURITY "NOTCH" ARE THE
S.I.'S OF THE SECOND WORLD WAR.

BUT I AM CONCERNED ABOUT IS THE "OFFSET"
ANOTHER "NOTCH" (READ ANOTHER 22-CATCH TO
SHORT THE S.I.) WHICH TAKES AWAY HALF OF

WHEN I PAID INTO THE SYSTEM, I WAS NOT ALLOWED TO MAKE ONLY HALF THE CONTRIBUTIONS OTHERS MADE. SO FOR 48-49 YEARS TOTAL, I GET SOMETHING LIKE, TOTAL 13,000 ANNUALLY AFTER TAXES, MEDICARE ETC. TO LIVE ON.

NOW, I UNDERSTAND THE GOV'T. "BORROWED" SOMETHING LIKE 450 \$ BILLION FROM SOCIAL SECURITY (INCLUDING HALF MY SOCIAL SECURITY BENEFITS WHICH WERE TAKEN AWAY FROM THOSE WWII VETERANS IN THE SOCIAL SECURITY ACT OF 1982) AND WHICH HAS BECOME PART OF THE 4 \$ TRILLION DEBT WHICH MEANS WE SOCIAL SECURITY CONTRIBUTORS WILL NEVER GET BACK.

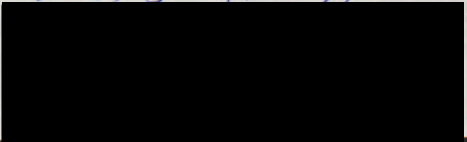

OF ALL THE LOUSY, STUPID RHETORIC ABOUT
VETERANS OF WWII. NO OTHER COUNTRY, NOT

ITS' VETERANS LIKE THE UNITED STATES.

HOW COME YOU, MR. BRIAN LAMB, NEVER

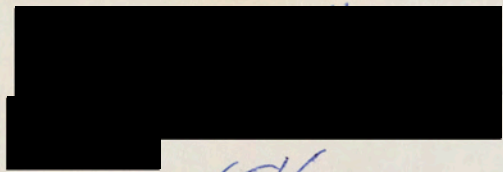
