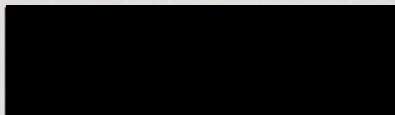
This attached Petition to the Congress of the

The Petitioner, [REDACTED], a Senior citizen, retired, residing at [REDACTED] City of Ormond Beach, County of Volusia, State of Florida, Petitions the Congress under the authority of the First amendment of the Constitution, seeking redress for actions taken, and/or about to be taken by hearings.

In the matter of: - Congressional Committees Investigations - Allegations of;

TREASON & CRIMINAL ACTS

This Petition is filed under the Petition Clause of the First Amendment of the United States Constitution, and the Petitioners Rights as a Citizen to Question, WHO SHALL INVESTIGATE.

Under Article 1 Sec. 5 Cl.2-(2) - It states that; Congress has the power under the Constitution to summon witnesses before either House of Congress or before their committees" - and - Congress in conducting an investigation through a committee, may compel disclosure of facts, pertainate to the inquiry."

Under Article 1 Sec.1 it is stated that; "The Congress is charged with safeguarding of- meaningful Judicial review, is one of primary function of docturine, prohibiting undue delegation of legislative powers."

1. The Petitioner prays that the Congress of the United States under the First Amendment of the Constitution, not only hold as law, but believe that public discussion is a public duty, and as such should be a fundamental principal of AMERICAN government.

CONGRESS HAS WOKEN THE AMERICAN PEOPLE

2. The Petitioner prays that the Congress will accept this petition as a "grass-roots" Hum and Cry being raised through out our great nation as dessenting voices of Congressional actions. Congress is reminded that they all should accept the absolutist approach advocated so consistently by Mr. Justice Black who stated; " freedom to speak and write about public questions is as important to the life of our government as is the heart of the human body; if that heart to be weakened the result is debilitation; if it be stilled, results are death."
3. The Petitioner prays that this petition also serve as NOTICE this 20th day of November 1991, that the people demand, equal JUSTICE for all, in all Congressional Committee Hearings, and Congress is charged under Article 1 of the Constitution, to safeguard all testimony, materials, documented facts, that may be pertainate to Judicial review and/or trial.
4. The Petitioner prays that Justice be returned, and to be the most consideration at any Investigating Hearing , and you the Congress men and women are admonished NOT to exercise your power in an arbitrary or dictorial manner, and that all Congressional minds shall be with a passion for JUSTICE.
5. The petitioner pray for a reversal of undue delegation of power to the "task force" to Investigate-ISRAEL-REAGAN-BUSH-IRAN affair, with allegations of TREASON and CRIMINAL ACTS. Stated by Re/ Hamilton, purported chairman, I'll select staff, and hire "TWO" Investigators. This statement shocks the very conscience of any reasonable person. and this hearing is to determine the Guilt or innocence of a Former and Present President and their staff--Unbelievable.

6. The Petitioner seeks proper redress, that NO staffer, clerks administrative assistants, be permitted to Interview and/or Interrogate any witness, as NOT trained to Investigate, nor authorized nor is there authority, as required in 90% of these United States, "To be qualified to Investigate, you must have at least three years Police related Investigations."
7. The Petitioner prays under Article 1 Sec.8, that Tax-payers monies have been wasted by the Hundreds of thousands of dollars in the Fisaco Hearings of North & Poindexter- Thousands of pages of documents, untold hundreds of hearing hours, and the Courts DID reverse their convictions, as a direct result of the poorly, inexperienced hearings. Congress shall not waste the taxpayers funds for clerks to Investigate a President of the United States for Treason.
8. The Petitioner prays that Congress through a proper delegation of power, select "TWENTY" Police Investigators, detach "Two" from ten first class cities, (as done daily) Each required to have ten years minimum Police Investigations into Criminal matters. The Majority and Minority leaders from both sides should in fairness select five cities each, for such Investigations. The cost will be far less, than the "TWO" proposed by Rep/ Hamilton, as Congress will only pay each City for "time", not wasted Hugh profits, on those who never did INTERROGATE..
9. That NO chairman be permitted to hand pick Special Counsel, this petitioner prays, that such staff be equally divided by selection of the Majority and Minority speakers, and They should be detached D.A. Prosecutors, save a million.
10. The allegations include two foreign countries, Israel & Iran, and the petitioner prays, NO MEMBER OF CONGRESS, that takes Pro-Israel Pac Money, or Iran Pac money, be permitted to sit on such Investigation as "CONFLICT OF INTEREST. Both Chairman of Foreign relations committee should NOT sit as both have taken hugh sums from Pro-Israel Pacs, Rep/ Hamilton, and Sen. Pell. and many of their committee members.

11. The Petitioner cites sources, and prays, The congress to to examine the Federal Election Commission records, and also an excellent source is Center For responsive politics, Washington DC. It is shocking to see so many members on the Foreign Relations committees taking so much Pro-Israel Pac funds, This investigation should never display anyone with a Total conflict of Interest, as Israel is alleged to have shipped arms, profited and aided the conspiracy.
12. The petitioner prays, No fisaco, of holding hearings, wasting Tax-payers funds, and then display a total ignorance of law, and permit thru lack of knowledge, the guilty to go free. The fisaco of April Glaspie hearings, before the Senate Committee, "Chairman pell-" Oh this is just a conversation", no record is needed" ?? Was there a conspiracy towards IRAQ? A second fisaco, Chairman hamilton did absolute nothing, as Glaspie stated " Oh I can't state that"..Yes Article 1 is the Law for such questions..The word "COMPELL
13. The staffers who are attorneys, this petitioner prays shall be directed to research every law on the subject, Should James Baker, Alex. Haig, state thats confidential, or I have Executive privilege, know they DO NOT...Read the powers of Congress, and the Cases held, Nixon v. United States, and so many others, plus Marbury (1803) v. Madison of Sec/State. Have staffers read and know, U.S.C.A. Sec.s 22 Foreign relations, Exporting of arms, the conflict of Israel being in any law..Especially the Law of Impeachment, and later-Trial. The Criminal laws applicable should be copied and known.
14. The Petitioner prays, should Congress wish staff involved, have Staff, read, the books with allegations, "October Surprise, When the Hostages didn't come home, The Commanders, and Gary Sick's book, TV programs and tapes available, and The Sampson Option. Then list every person for INVESTIGATORS to decide -Interview or Interrogations.

15. The Petitioner prays, that the attached list of Pro-Israel Pacs from Center for Responsive Politics be used to assure there is No Representative or Senator sitting on such Investigation, that would be a direct "Conflict of Interest" The attached lists indicate the sum of four million, \$4,031,662 was taken from israel Pro-Pacs.. This Hearing must be fair and with Integrity to re-establish faith in the Congress.
16. The Petitioner prays NO IMMUNITY be granted except with the authority of Special Counsel, and the Majority and Minority leaders, and established financial reporting procedure be immediately established for any review and accountability by the General Public.
17. The Petitioner prays this Investigating shall be all encompassing, accepting all information, and not as alleged that Congress had No interest in the subject during the Iran-Contra-hearings. Inexperienced staff-again? Or purposeful? Was North involved in 1981 as a Major?
18.
