LANTOS SPEECH ON HUD HEARINGS TO AIR ON C-SPAN

C-SPAN will air an address by Rep. Tom Lantos (D-Calif.) entitled "The Long HUD Summer" on Sunday, October 1, at 11:30am ET/8:30am PT.

Lantos' speech before the Woman's National Democratic Club, which takes place September 28, will focus on his role as the chairman of the House Government Operations subcommittee on employment and housing. The subcommittee held more than 20 hearings this summer to consider charges of influence-peddling and favoritism at the Department of Housing and Urban Development.
