C-SPAN AIRS FORMER PRESIDENT REAGAN'S VIDEOTAPED TESTIMONY

Washington, D.C., March 21 -- C-SPAN will air the videotaped testimony of former President Ronald Reagan from the Iran-Contra trial of John M. Poindexter as the individual tapes are released to the news media.

Judge Harold Greene is providing the news media with each videotape immediately after it is played at the trial of the former National Security Advisor.

The first segment of the testimony was aired at the trial this afternoon. C-SPAN will air that portion tonight at 8pm ET/5pm PT.

C-SPAN will air each day's released videotapes at 8pm ET/5pm PT that evening. In the days to come, the public affairs network will air all eight hours of Mr. Reagan's testimony uncut and in its entirety.
