C-SPAN LOOKS AT THE COURT OF MILITARY APPEALS

C-SPAN will air a three-hour special focusing on the U.S. Court of Military Appeals on Friday, July 14, at 8pm ET. The special will include taped interviews with judicial experts, two justices from the Court of Military Appeals, and an oral argument before the court. A live Viewer Call-in program will feature Judge Robinson Everett, chief judge of the U.S. Court of Military Appeals.

The court, established in 1950 by Congress, is designed to insure a balance between a disciplined armed forces and the desire to give service personnel accused of crimes rights that parallel civilians.
