Washington, D.C., October 4, 1989 -- C-SPAN will air a seminar sponsored by the Washington Journalism Center entitled "Journalism Ethics in Perspective" on **Saturday, October 7, at 11am ET**, and again on **Monday, October 9, at 10am ET**.

Journalists who scrutinize the ethics of newsmakers will take a close look at ethics issues in the journalism trade. Among the topics addressed are reporters' use of unnamed sources, conflicts of interest, and the acceptance of honoraria.
