heart oper this oper heart.

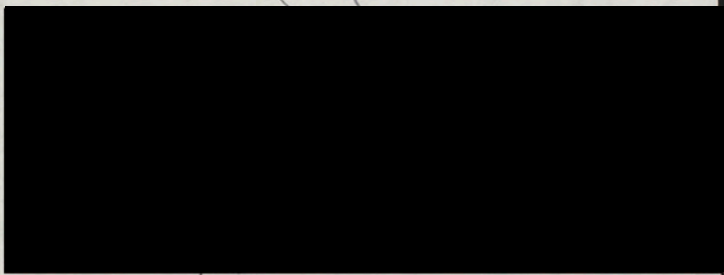
I have insurance the cost is killing
