Dear Sirs:

During the morning of January 26, 1994, C-SPAN carried a discussion of the effects of technology on freedom. I found the program to be very interesting, as is most of the C-SPAN programming. However, I found myself outraged by a question asked by one of the reporters covering the meeting. I realize that C-SPAN is not and should not be responsible for opinions expressed, so my outrage is not at you. But since the reporter did not identify himself, you are the easiest target. Hopefully you can identify the reporter and his organization and forward my comments on to the appropriate people.

The question came during a discussion of the pros and cons of the much touted "Electronic Town Hall," and specifically with the ability of participants in the meeting to vote instantaneously by electronic means on issues under discussion. Unfortunately I was not recording the event, so I cannot quote the question exactly, but I can come very close. The reporter prefaced his question with a statement that went something like this. "A large percentage of Americans have trouble reading and writing and, according to a recent poll conducted by my competitor, Time Magazine, a full 60% of the respondents believed in angels."
