I was extremely interested in what Mr Blum had to say and I understand also that he is editor of a magazine "For the Defense." Do you have an address for the magazine or for Mr. Blum? I would like to order a subscription and also get in touch with a national organization concerned with changes in our judicial system to improve the guardianship of individual

rights.

It is very difficult to find any information on the defense of individuals who should be considered "innocent until proven guilty", but because of lack of funds is at the mercy of the court, often to his detriment.

With the increase efforts on the drug problem (and rightfully so) there should also be an increased effort to be as certain as possible that innocent persons do not get "caught" in the net. Much needs to be done toward additional investigation before trial and rehabilitation in case of sentencing. We do not need more innocent persons in jail nor do we need longer sentences than are deserved.

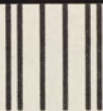

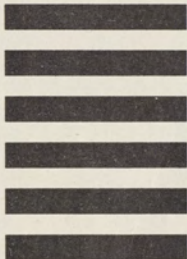
