I am writing because I saw A. Malveux on C-SPAN this morning discussing 'race'. Specifically, the assault by blacks on a white reporter at a DC School, now being investigated by the Justice Department as a hate crime. Her and the other guest simply did not respond to the question!

This case is not an isolated incident. As a 10 year suffering resident of this Dysfunctional City I can attest first hand to the racist attitudes of blacks in this city. The problem is that blacks have redefined racism in such a way that their own attitudes and behavior are exempt. Therefore, when blacks are murdering asian merchants, the black political establishment yawns and embraces hatemongers like Willie Wilson. When a 19 year old black male shoots a Senator's Aid in the back of the head because 'he felt like shooting a white man', not only is there no outrage, it takes two trials to convict him. When an antisemite comes to town to denounce whites, he is not only given the keys to the city, but allowed to use government property while violating civil rights statutes prohibiting the exemption of individuals on the basis of race and sex {Farrakan at the DC Convention Center and Armory over the last ten years} Blacks on the DC Council vote to give the man an award?! How many blacks (other than the perpetrator) died in the attack on police headquarters by Bennie Lawson? Shades of Colin Ferguson, isolated, or what? I could go on but you get the point.

My wife and I have been on the receiving end of repeated assaults, threats to our lives, vandalism to our vehicles and property, and repeated burglaries (even while we were home). In spite of repeated attempts to get this harrassing treatment classed as a hate crime, I have finally realized that this city deliberately suppresses these kinds of statistics and the true nature of a majority of the interracial crime in this city! This complicitous behavior extends to the current DA, Mr. Holder and the current Police Chief, and the people he manages including Inspector Proctor at the 3rd District Police Precinct, whom I have repeatedly tried to get involved in this matter.

While Ms. Malveux was arrogantly dismissive regarding the attack on the white reporter, my wife and I consider this issue at least as important as bad service at Denny's, and know first hand that it is a daily occurence in this (and other) cities across the country. Apologists for racists blacks and their violent behavior won't cut it anymore. Had a fraction of what has occurred to us been inflicted on a black couple in the suburbs, there would have been hell to pay, gar-on-tee!

A secret told

"The issue of black-on-white crime is the dirty little secret of American society — something almost everyone knows about or suspects, but no one discusses. To discuss it, in fact, is to run the risk of being stigmatized as a racist. Yet this is a problem which is worsening, particularly as a generation of 'super-predators' comes of age. In the last 28 years, violent crime has increased four times faster than the population, which means that a sizable segment of the population is working overtime committing crimes. It's no mystery who comprises this segment: young people. And black males under the age of 18 are 12 times more likely than whites in the same age group to be arrested for murder.

"According to the Justice Department's 1993 'Highlights from Twenty Years of Surveying Crime Victims,' of the more than 6.6 million violent crimes committed annually in the U.S. (comprising rape, robbery, assault, and mur-

der), about 20 percent are of an interracial nature. Most of the victims of these crimes — at least 90 percent — are white. According to the FBI's annual murder report, for instance, blacks murder whites at 18 times the rate that whites murder blacks."
