**--As New Term Begins, In-Depth Look at the Issues Before the Court--**

Washington, October 9, 1992--Tomorrow, Saturday, October 10, C-SPAN's "America and the Courts" will air "First Monday in October," a special look at the 1992-93 Supreme Court term that began last week.

From C-SPAN studios, Professors Steve Wermiel, Georgia State University Law School, and Tom Krattenmaker, Georgetown University Law Center will look at the cases on the docket, who's who on the Court, the Court's direction, and its coverage in the media.
