**THANKSGIVING DAY ON C-SPAN "AN AMERICAN PROFILE" OFFERS IN-DEPTH
CONVERSATIONS WITH CONGRESSMEN KASICH AND MFUME**

Washington, D.C., Tues., Nov. 23, 1993-- On Thanksgiving Day, Nov. 25, at 8:00 AM, 8:00PM, & 12:00 midnight (ET), C-SPAN will air two hour-long interviews on "An American Profile," its holiday program featuring America's leaders.

This time C-SPAN will focus, in alphabetical order, on the personal lives and careers of Rep. John Kasich (R-OH) and Rep. Kweisi Mfume (D-MD).

In the first hour Rep. Kasich takes a break from his active life to reflect upon the forces that drive him and his political convictions. The following hour highlights the compelling story of Rep. Mfume's childhood and his personal and political development.

C-SPAN's "An American Profile" airs on holidays and highlights aspects of the lives and personalities of America's leaders, rather than just their positions on the issues. Two hour-long conversations with two individuals from different political perspectives air back-to-back.

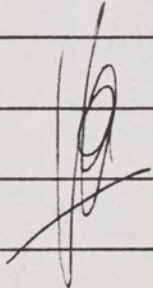

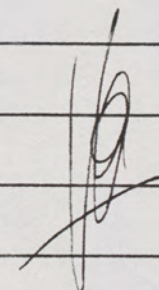

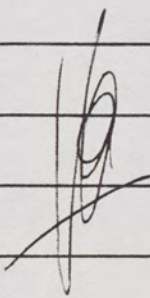
