C-SPAN MT Section getting B-page reshuffled

June 1 may be a dark day for political junkies.

C-SPAN, which provides 24-hour coverage of the U.S. House of Representatives and other public affairs doings, will be dropped from the local cable line-up offered by TCI-Cablevision.

Replacing the cable stalwart will be a rookie: fX, a new venture from FOX Broadcasting. A notice in TCI bills describes the new offering as "original, entertaining and sometimes interactive."

Wes Huffman, TCI's Great Falls manager, said he has few details of exactly what kind of programming fX will include.

"It will be a family-oriented kind, of general programming," Huffman said.

C-SPAN won't be lost completely. Since the notices in monthly cablebills were mailed, TCI has worked a deal with Channel 7, the publicaccess station, to carry some C-SPAN programming.

The public access coverage won't be in prime time. It will stretch from midnight to 10 a.m.

"We won't have to drop it totally," said Huffman.

The decision to put the fX on Channel 19 wasn't made haphazardly, Huffman said. Contractual obligations require TCI to carry the new channel. The current cable system is handling all the channels it can. Something had to go.

Relying on surveys, conversations with customers and other methods, TCI determined that C-SPAN was the least-watched of the local cable offerings, Huffman said.

"There were only a few channels that we could even consider dropping and C-SPAN was one of them," he said.

A Washington D.C. spokeswoman for C-SPAN said a number of other cities served by TCI apparently will lose the public affairs programming.

There has been some static from local viewers, Huffman said.

"It does provide programming that isn't available anywhere else," Huffman said. "I'm sure people who are really attuned to that channel will be concerned. For others, they probably never watch it."

The loss of C-SPAN from the cable line-up may not be permanent. TCl has launched a \$14 million program to rebuild its local system with fiber optic cable over the next two years

C-SPAN gets a stay, will be aired on two channels

C-SPAN has found new life on local cable TV.

TCI Cablevision has backed off plans to dump the public-affairs channel. Calls and letters of protest helped save the channel, said Wes Huffman, TCI's local manager. Most presented rational arguments for the programming, he said.

"I was pretty impressed with the attitudes people showed" toward public affairs programming, Huffman said Friday.

Last week, the cable company announced its intent to drop C-SPAN, now on Channel 17, and replace it with fX, a new channel from FOX Broadcasting. Company officials said they were required to carry the new channel and lacked capacity to add channels. C-SPAN appeared to be the least popular channel in the line-up, they said.

Channel 7, the public-access station, would have carried some C-SPAN programming under the proposed arrangement.

The new deal will have C-SPAN available from 6 a.m. to 6 p.m. Monday through Friday on Channel 5, which is currently used to promote offerings on premium channels and pay-per-view offerings. Channel 7 will broadcast C-SPAN from 1 p.m. to 8 p.m. on Saturday and 1 p.m. to 9 p.m. on Sunday.

The changes in programming will take place June 1.
