ABORTION RIGHTS CONFERENCE AIRS ON C-SPAN

Washington, D.C. -- C-SPAN will air three speeches from the National Abortion Rights Action League (NARAL) on **Saturday, October 14, at 10:30pm ET/ 7:30pm PT**. The conference, entitled "Political Strategies for a Pro-Choice America," takes place in Washington, D.C. October 13-15.

C-SPAN's coverage of the conference will feature addresses focusing on the current legal status of abortion and NARAL's strategy for preserving womens' right to abortion. Walter Dellinger, Duke University law professor, will discuss "Where Are We Now? A Supreme Court Update" and Kate Michelman, executive director of NARAL, will outline the organization's political action plan. New York City mayoral candidate David Dinkins will give the keynote address.
