C-SPAN NAMES STEVEN SCULLY POLITICAL EDITOR

Washington, D.C., June 15 -- Steven Scully has been named Political Editor for C-SPAN, the Cable Satellite Public Affairs Network.

Mr. Scully, formerly a reporter for WHEC-TV, Rochester, NY, will oversee the network's political coverage beginning with the 1990 gubernatorial and congressional elections.

A native of Erie, PA, Mr. Scully received his bachelor of arts degree in political science and communications from American University in Washington, D.C. in 1982. He also holds a master's degree in journalism from Northwestern University. He has worked as a Capitol Hill press aide, a reporter for WAMU-AM in Washington, D.C., and a reporter for WSEE-TV in Erie, PA.

While in Rochester, Mr. Scully served as an adjunct faculty member at Nazareth College and St. John Fisher College.
