SAM PIERCE FACES QUESTIONS FROM COMMITTEE INVESTIGATING HUD
Former Secretary's Testimony Live on C-SPAN

Washington, D.C., September 14--C-SPAN will air live the testimony of former Housing and Urban Development Secretary Samuel Pierce before the House Government Operations Employment and Housing subcommittee Friday, September 15, at 9:30am ET/6:30am PT.

The subcommittee, chaired by Rep. Tom Lantos (D-CA), is investigating alleged wrongdoing that occurred at HUD while Mr. Pierce was secretary. It will be the first time since May 25 that Mr. Pierce has been questioned by the committee.

C-SPAN will re-air the committee hearing in its entirety Friday evening at 8pm ET/5pm PT.
