President Reagan; Senators Hatfield and Packwood; Representatives AuCoin, Wyden, B. Smith and D. Smith; Senate Candidate Rick Bauman; Representative Candidates; Tony Meeker, Barbara Ross and Larry Tuttle.

During the last four years I have written hundreds of letters and have received a few answers in return.

The substance in these letters leads me to believe there is a chance that most of you are either involved in, or are aware of a cover up to prevent an investigation of the Oregon State Board of Engineering Examiners and the ethics committee chairman of the Professional Land Surveyers, Willamette Chapter.

The governor of Oregon appoints the OSBEE members to office. The OSBEE appointed the P.L.S. to investigate allegations that an assessors map for assessing taxable acreage and a road right-of-way map for acquiring right-of-way property were falsified to show a tax lot 602 was physical property instead of property on maps only.

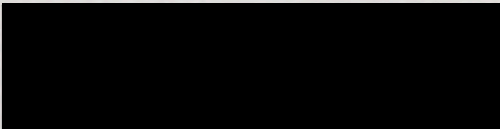
