C-SPAN AIRS LIVE COVERAGE OF THREE KEY POLITICAL RACES

Florida, Massachusetts, California Governor's Races Featured

Washington, D.C., October 29 -- With Election Day one week away, C-SPAN intensifies its "Election '90" programming with live coverage of three of the most hotly contested governor's races in the nation.

C-SPAN will air live candidate debates from Florida and Massachusetts and will feature live coverage from California of the governor's race between former San Francisco Mayor Diane Feinstein and Senator Pete Wilson.

On Tuesday, October 29, beginning at 7:00 PM (ET), C-SPAN will televise the Florida gubernatorial debate between Gov. Bob Martinez (R) and former Senator Lawton Chiles (D). This debate will be live from Orlando and is sponsored by WCPX-TV and Florida's CBS affiliates.

Also on Tuesday, at 8:00 PM (ET), C-SPAN will air the Massachusetts governor's debate between Attorney William Weld (R) and Boston University President John Silber (D) live from Boston. This debate is sponsored by WCVB-TV and the Massachusetts Broadcasters.

C-SPAN's "Election '90" programming provides viewers with comprehensive coverage of the key House, Senate, and gubernatorial elections.

C-SPAN is available in 50.9 million households nationwide and around the world via satellite. The network is privately funded and is a public service of the cable television industry.
