**C-SPAN MARKS MEMORIAL DAY WEEKEND WITH SPECIAL
PROGRAMMING ON VIETNAM AND POW/MIA AFFAIRS**

Dallas, Texas, May 5, 1992 -- This Memorial Day weekend C-SPAN, the Cable Satellite Public Affairs Network, will take viewers on an in-depth tour of Vietnam today, with moving and comprehensive footage taken from a recent week-long tour accompanying members of the Senate Select Committee on POW/MIA Affairs.

C-SPAN's cameras traveled to Ho Chi Minh city, Hanoi, the Mekong Delta, Danang and other small villages with the Senate delegation. The programming shows the details of overseas travel in a Senate delegation; how the trip is organized and structured, official contacts with host country diplomats, and personal conversations with the people as the Senators pursue their objective. C-SPAN's long-form programming shows the places and panorama where American soldiers fought and lost their lives, from deserted battle sites to tiny thriving jungle villages which once were war-torn territories.

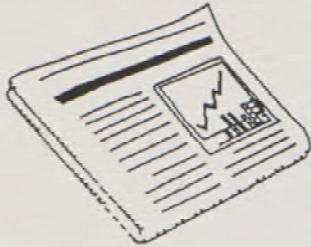
The network's signature video verite style coverage takes the viewer on a walking tour of the Ho Chi Minh Mausoleum, a prosthetic research center, an Amerasian center, a pediatric hospital and into the Ho Chi Minh City College. The program includes a variety of interviews with local people, American students studying in Hanoi, Vietnamese government personnel and the American Senators. An in-depth portrait is painted of Vietnam today revealing the people's attitude toward Americans, their memories of war and current information about prisoners of war.

The program will air during the Memorial Day Weekend and taped footage will be interspersed with Live Viewer Call-In programs featuring in-studio guests who will comment and guide viewers through the travels.
