-- C-SPAN TELEVISES U.S. CONGRESSIONAL SUMMIT ON DEBT AND TRADE --
-- Policymakers Discuss International Economic Issues at NYC Conference --

WASHINGTON, D.C.-- C-SPAN cameras travel to New York City for complete coverage of the U.S. Congressional Summit on Debt and Trade, December 4th and 5th.

Sponsored by Members of Congress, the conference goal is to fuel a rethinking of U.S. domestic and international economic policy. C-SPAN cable network plans to televise the entire meeting on a tape-delayed basis throughout the month of December.

The Congressional summit will focus on the link between debt and trade, and their effects on world economy. Members of Congressional budget and finance committees have invited business, labor, academic, financial, and foreign leaders to participate in a dialogue examining global economic problems and possible solutions.

C-SPAN's unedited telecasts will feature conference roundtable discussions about Third World, farm, and corporate debt policy issues.
